Why the CAN I LIVE Section 8 Housing Forum:

The Can I Live Section 8 Housing Forum is a multifaceted gathering which primary focus is to facilitate dialogue among housing stakeholders by gathering its thought leaders, residents who receive subsidies, mission driven landlords, housing developers, community based organizations and government officials to increase access to affordable housing and homeownership opportunities for Housing Choice Voucher and Public Housing program participants and to spur innovation in reinvestment and community development opportunities.

In Today's hot real estate markets, there are little to no incentives for landlords to rent to low-income families through the HCV program. Although the program offers on-time and consistent rent payments every month, both landlords and tenants are faced with a plethora of challenges that serve as barriers to renting and finding adequate affordable housing throughout the state of Virginia. Through our One Million Moms OFF Welfare Initiative, Can I Live will host a series of regional forums aimed at streamlining and closing the gaps in this nation's stable affordable housing program—Housing Choice Voucher.

It is important to note that as Public Housing Authorities (PHA's) undergo major redevelopment through the RAD (Rental Assistance Demonstration, LICTC (Low-Income Housing Tax Credit) and other affordable housing development programs; public housing residents in most cases will be granted Section 8 vouchers to assist them in their relocation efforts. The shortage of available landlords is proving disastrous for housing staff and their budgets but will also contribute to an increase in homelessness if not adequately coordinated and supported.

To this end, there is no better time to support the CAN I LIVE Section 8 Housing Forum.

- Incentivize and increase Mission Driven landlord HCV participation
- Educate Lender's on the benefits and process of working with the HCV program
- Increase and strengthen rental and homeownership options for public housing and HCV program participants

Rent Readiness: Finding Your Next Section 8 Property to Rent

Whether you're starting your search on craigslist or other affordable housing sites, the one thing you're sure to find are the phrases... "this property has a waiting list or Not Accepting Section 8". The goal is for you to leave this workshop with the tools and techniques you need to get landlords to say "yes" to you and not "No" to your section 8 voucher.

Let's Level the Playing Field: Utilizing Your Voucher for Homeownership

It's amazing to know that so many Section 8 voucher holders are not aware that they can use their voucher to purchase a home. The question then remains is, do you understand what homeownership can do to help you change the game? HCV program participants must qualify on all fronts just as everyone else. This workshop will educate lenders on the benefits of writing mortgages for the HCV program participants and navigating the process.

WANTED: Mission Driven Landlords: Using Your Property to Foster Self - Sufficiency

There's no question about it! There would be no Section 8 program if it were not for the benevolence and prosperity of our landlords and investors.

Despite the horror stories, there are many ways to utilize your properties to foster personal accountability. This workshop will educate landlords on new HUD rules that would allow one to foster economic independence for renters.
