2. Before setting up, you must check in at the registration table to get your space assignment, pay all balances due and get your dealer badges and vehicle pass.
3. Set up time: Friday: 8:00 am to 5:00 pm
4. Show Hours: Early Buyers: Friday 12:00 noon to 5:00 pm • General Admission: Saturday and Sunday 9:00 am – 5:00 pm • Sunday 9:00 am – 4:00 pm
5. You must be completely set up by 5:00 pm on Friday and remain completely set up until the show closes at 4:00 pm on Sunday.
6. Puchstein Promotions and Indian River County Fairgrounds are not responsible for any loss, damage, theft, accident or injury of any kind on the premises.
7. All items must be priced. No “bargain”, “special”, “close-out”, “half price”, or other signs permitted.
8. Booth must be attended by dealer or a representative at all times the show is open to the public.
9. Rental tables must be reserved when contract is returned. You must pay for all tables ordered, even if you change your mind when you arrive.
10. No restrictions on table covers, but keep your booth neat & clean at all times and conceal all boxes.
11. Everyone must be packed and exiting the Fairgrounds by 9:00 pm on Sunday night.
12. RV hookup facilities available through Indian River County Fairgrounds at \$20.00 per night.
13. \$50 DEPOSIT required to reserve space. BALANCE due at check-in.
14. Booth rent is NON-REFUNDABLE and NON-TRANSFERABLE.
