Overview: Creating a church budget is more than a financial task—it's a spiritual discipline that reflects stewardship, planning, and vision. For AME churches with average memberships between 25-100, a thoughtful, realistic budget helps align ministry goals with available resources.

In the life of the local AME Church, budgeting is not just about balancing numbers—it's about faithfully managing God's resources to fulfill the mission, sustain ministry, and support the Connectional obligations that bind us together in Christian service

Understanding Church Income - Tithes and Offerings - Special Events/Fundraisers - Rental Income (if applicable) - Grants or donations from outside organizations - Bequests or legacy giving

Understanding Church Expenses - Worship & Ministry (supplies, guest preachers, music, etc.) -Pastoral Compensation (salary, housing, benefits) - Utilities (electricity, water, gas, internet) - Insurance (property, liability) - Connectional Giving (AME assessments, District support) - Administration (office supplies, technology) - Outreach and Missions

Budget Planning Process - Review previous year's actual income and expenses. - Meet with finance team and pastor. - Establish ministry goals for the year. - Project realistic income. - Allocate funds to priority areas. - Include a contingency line item (5-10%). - Present budget to the Official Board for approval.

Tips for Congregations - Keep it simple and clear. - Be conservative in income projections. -Consider bivocational leadership if needed. - Emphasize stewardship education. - Encourage recurring giving (online and in-person).
