DURING 2018 THERE WERE 859 PROFESSIONS OF FAITH AT THE MEDICAL OUTREACHES. SINCE THE INCEPTION OF CIRCLE OF LOVE FOUNDATION, 109 MISSION TRIPS HAVE TAKEN PLACE AND PROVIDED OVER 100,000 INDIVIDUALS WITH FREE MEDICAL CARE. 28,577 PROFESSIONS OF FAITH HAVE OCCURRED DURING THIS SAME TIME FRAME.
