MEDICAL OUTREACHES WERE HELD IN THAILAND AND GUATEMALA. 1,481 PATIENTS WERE EXAMINED AND TREATED. 11,152 PRESCRIPTIONS WERE FILLED AND 347 PROFESSIONS OF FAITH WERE MADE AT THE MEDICAL OUTREACHES.
