Florida Antique Shows (FAS) reserves the right in its sole and unfettered discretion to 1) determine the eligibility of exhibitors and exhibits for the show, 2) reject or prohibit exhibits or Exhibitors which FAS considers objectionable, disruptive or inappropriate, 3) change or modify the layout of the Show and/or relocate exhibits or Exhibitors, 4) cancel in whole or in part the Show due to an event or force majeure 5) change the date, location and duration of the Show, without any liability to FAS or 6) cancel in whole or in part the Show at anytime.

You agree to be at and have your display open to the public during the advertised show hours. Pets are not permitted inside any of the buildings or any part of the facilities at the Show. Counterfeits, fakes or replicas of brand name items are prohibited. If counterfeit merchandise is found, you will be asked to leave the show, your booth rent will not be returned and a police report will be filed. Confirmation of spaces, vehicle passes and exhibitor badges will be sent prior to the event. FAS reserves the right to establish and amend or modify any regulations governing the use of the facility and the Show. Liability Agreement Neither FAS, the promoters, Seminole Casino Coconut Creek, their representatives, agents, employees or any members of guests of the FAS and/or the facility on which the activities are presented is responsible for any injury, loss or damage from any cause whatsoever that may be suffered by any vendor, their employees, agents or property. The vendor, upon execution of this agreement, expressly releases the foregoing-named association, parties, individuals and employees from any and all claims for such injury, loss or damage. The Vendor further agrees to save and hold each of the foregoing named associations, parties, individuals and employees harmless from any claim or demand on account of any bodily injury or physical property damage caused by or resulting from any negligent or willful act of Vendor, their representatives, agents or employees in the operations of Vendors business, display or exhibit. FAS will provide security during closed hours of the event to patrol the facility. However, no responsibility is assumed by FAS and Seminole Casino Coconut Creek, WPBAF or the promoters, their agents or affiliates for goods delivered to or situated at the FAS facility during the event operating hours or material left on the premises after the event closing hours. In its' 34th year, the **Stuart Antique Show** returns Thanksgiving weekend November 24,25, 2018 with its first of 3 events. Other dates are January 12,13, 2019 and March 9,10, 2019. The entire show is held inside the Martin County Fairgrounds. 35 of the 100 spaces are air-conditioned and all spaces are on a wall.

The 23rd **Vero Beach Extravaganza** will only have 1 big show hosting 300 dealers-January 25,26,27, 2019. Inside air-conditioned, outside covered, and outside field spaces are available at the spacious Indian River County Fairgrounds.

The **Seminole Casino at Coconut Creek** will host the 3rd Antiques and Vintage Jewelry Show. This will be a small show with 40 dealers and will be held February 1,2,3, 2019. Both Casino shows held last year were very successful.

The **West Palm Beach Antiques Festivals** are Florida's largest Antique Shows. The average show hosts 400 dealers at its' permanent home, the South Florida Fairgrounds. Now in its 29th year, this mega show is held the first full weekend of every month except for the huge 1000+ vendor February "Spectacular" show. It is being held the second weekend February 8,9,10, 2019 due to the Florida State Fair taking place the first weekend of February.
