5. You must be completely set up by 5pm Friday and remain completely set up until the show closes at 4pm Sunday.
6. Puchstein Promotions and Indian River County Fairgrounds are not responsible for any loss damage, theft accident or injury of any kind on the premises.
7. No 'bargain', 'special', 'close-out', 'half price', or other discount signs permitted.
8. Booths must be attended by dealer or a representative at all times the show is open to public.
9. Rental tables must be reserved when contract is returned. You must pay for all tables ordered even if you change your mind when you arrive.
10. No restrictions on table covers but your booth must be kept neat and lean at all times.
11. Everyone must be packed and exiting the Fairgrounds by 9pm Sunday.
12. RV hook-up facilities available through Indian River County Fairgrounds at \$20 per night plus tax.
13. \$50 DEPOSIT required to reserve space. All balances are due at check in.
14. Booth rent is NON-REFUNDABLE and NON TRANSFERABLE
