Upon establishing the presence of a quorum, Board Chair Jenny Doud called the meeting to order at 12:20 p.m. and opened the meeting with prayer.

Sonny Dodson moved to approve the minutes from the December 13, 2020 Board meeting as presented. Becky Moore seconded the motion. The motion carried and the minutes of the meeting were approved as submitted.

Reports

Finance: Carlton Altizer presented a review of the 2020 year-end budget highlighting additional expenses for telecommunication. He said it had been a good year considering everything that changed with the pandemic. He also mentioned that we had been able to give an increase to the officer manager and custodian at mid-year. A copy of the funds report from January-December 2020 is attached and is made a part of these minutes. The Chair suggested that a strategic plan be developed in conjunction with the financial plan. With regards to the continuing use of space by Radford City Schools, a question was raised concerning the cost of utilities for that usage. Wendy is in contact with Rob Graham and Pam will research the use to establish a percentage of the cost of utilities. The Chair announced that the Congregation has approved the operating budget for 2021 with the amount \$301,722. She also announced that we have applied for CARES Act forgiveness of \$32,000 granted in the Payroll Protection Plan in 2020.

Pastor: Wendy presented the Pastor's report, a copy of which is attached and is made a part of these minutes. She reported that Unity will participate in the ringing of the bells on Tuesday, January 19, to remember those lives lost due to Covid-19. The office will be closed on January 20.

Director of Faith Development: Hayden presented the Director of Faith Development report, a copy of which is attached and is made a part of these minutes.

Personnel: The Chair announced that Ben Bondurant has resigned as Trustees Chair and as a member of the Trustees. This item will be referred to the Personnel Team. Also, Pam announced that the staff review process will be moved to August.

Dear Church Family,

As we approach the one-year anniversary of the pandemic and how it has changed our lives and how we do church, the leadership team is taking some time to evaluate where we have been, where we are, and where God is calling us next. This has truly been a year where we have all been disconnected from each other and we have all missed one another. As one way to reconnect and show our shared love and hope for Unity, we are reaching out to everyone to get a clear assessment of how you feel and think about the church and where you see God leading us both in the near and distant future.

A Task Force has been established with members representing the different generations of our church and the various ministries we support. Someone from the Task Force will be contacting you to discuss and share the questions included. Our motto and mission is still to "Reach Up, Reach In, and Reach Out" but we need to ask ourselves, "What does that look like in the post-pandemic world?"

Our immediate sights are on reconnecting and renewing our commitment with followers, but also expanding our reach with our community. You are part of this journey of faith and your input is needed. As we develop our future, we are asking what realignments and staffing are beneficial and what will these do to help aid our commitment to our goals of:

- --Making and transforming disciples
- --Growing spiritually through prayer and other spiritual disciplines
- --Learning more about the Bible and our understanding of faith and how it affects our daily lives
- --Providing opportunities to serve our neighbors through mission

We've witnessed what stepping out in faith can do for Unity in the hiring of a director of faith development. During the last two years we've seen our youth and young adult ministries flourish with an expansion of our Children Worship and Wonder ministry, new growth in a community of families with children, and a second service added with a praise music team. We experienced almost a fivefold increase in our ministry's ability to reach individuals through virtual services on Facebook, Wednesday Word and Witness, weekday studies and other connections through virtual services and digital media. Last year alone our average weekly worship attendance was 609 people. We served approximately 2,095 people in our own community, and from 2019-2020 gifts and special offerings totaling over \$375,000 have blessed us with enormous opportunities. In spite of COVID, we were able to continue our commitment to reach up, reach in, and reach out.

As we look to the future, let us all ask, "How do we continue to build upon what Unity has started? How do we expand our ministry to further share the Gospel with our community and beyond?" Please take time to pray and reflect upon these questions. Your participation will help us understand God's vision for Unity in this new reality we find ourselves.

Guidelines For Interment in the Unity Memorial Garden

* The cremated remains of anyone who is a member and/or has a close relationship with Unity Christian Church (Disciples of Christ) of Radford, VA, may be placed in the Unity Memorial Garden. The burial of cremated remains of any other person will need to be approved by the General Board of Unity Christian Church.

* Containers that are watertight may be used. Ashes cannot be spread but must be in an urn and buried in the appropriate area of the garden.

* Markers will be placed where the ashes are buried. A record of placement for each urn and a map of the garden will be kept.

* Plaque name tabs can be obtained from Unity Christian Church. Only names of the interred and dates are to be noted on the tabs. The cost of the tab will be paid by the family of the deceased.

* The memorial garden must be kept as a serene, meditative area of the church property.

* The Property Team of Unity Christian Church will oversee the care of the garden.
