Upon establishing the presence of a quorum, Board Chair Jenny Doud called the meeting to order at 12:15 p.m. and opened the meeting with prayer. One item was added to the agenda: a proposal for a motorcycle run fund-raiser to support the Radford Clothing Bank.

Unity Christian Church Minister's Report Sept. 2021

Worship

- --So great to be back with you!!!
- --Tim Moore preached for me while I was a way officiating a wedding. Grateful for his willingness to do this and for him to have the opportunity as he begins to work towards the license ministerial program through the Virginia Region.
- -- This Sunday is a celebration with music and special recoginitions.
- --Next Sunday, Sept. 19 is National Back to Church Day. We will have a special service and block party after worship. Teresa Orange has been pulling together all the activities and needs for the block party. We hope to make it an opportunity for the church to be together and to welcome and include RU student. The funds we are using for this event are coming out of the sabbatical fund designated for meal on my return. Next Sunday we will also recognize those who participated in Summer Sabbatical Challenge.
- --From Sept.19-Oct. 24, I will be doing a sermon series on Altars in the World. There will be continued reflection on what I learned on sabbatical. I will be looking at some ways to emphasize stewardship and giving as well. Oct. 3 will also be World Communion Sunday.
- --Oct. 31 we will have an All Saints Service in which we will lift up the saints of the church that have died in 2021. It has been a hard year with 7 deaths and I think this service will help us all with our grief.

- --Daily phone calls with people and some one on one in person visits to homes. After the surveys came it out it was apparent that I need to do more checking in on our shutins. My goal is to make Mondays the day specific for calls and visits. Since my return from sabbatical, I have made 8 home/hospital/nursing home visits
- --Officiated at the destination wedding of Parker and Nourdjan Chrisman's wedding
- --Officiated at Geneva Mottesheard's funeral and beginning prep for Lila Lorton's.
- --Elders will be meeting on Sept. 22to revisit what it means to be an Elder and what Elders want to do at Unity Christian Church.
- --More Conversations with Tim Moore as he prepares to begin the Commissioned Ministry program of the region. I will be setting up his team this month to begin the support process.

Outreach

- --Community Table is going well and we are ready to open up to other Teams outside of our church. Grateful to all who cook and deliver meals.
- --Partnership with Daily Bread and Ridgewood is going well and everyone who participates seems to love being a part. We now have two weeks under our belt.
- --I believe work was done with Project Bluefield this summer. I loved seeing the video online of all the rooms. It is amazing what the team has done with the cabin. I love it!

Children/Youth/RU Students/Young Adults

- --Children Worship and Wonder starts back this Sunday with a special training for our three year olds. Gloria and Gina worked on the room and organized stories several weeks ago to prepare. We are having trouble scheduling storytellers and greeters. We need to look at having more of both responsibilities.
- --I heard One Day/All VBS and pool party went well. Not a lot of kids participated but those who did had a good time. I will follow up with Candace soon.
- --We currently having nothing in place for youth, college, or young adult programming. I do know that Kathy and Morgan who have served the youth faithfully are checking in on youth by text. Kathy Young took Erin Wilson to dinner last week.
- --The Mustard Seed Ministry for Children in Grades 1-5 will start back in October. Teresa Orange and Dottie Wheeler will lead the group and are both super excited about doing so. The group will gather two Sundays a month after worship.
- --Teresa continues to mail out children bulletins weekly and prepares the children's worship bags weekly.
- --We do have 4 regular RU attenders and had 2 new students come last week. I had a father of a student call me two weeks ago to ask me to check in on his son.

Evangelism

- --Facebook posts are AWESOME and getting lots of likes and shares. Becky Moore took this ministry on while I was on sabbatical and has willing accepted to continue doing this.
- --The congregational surveys revealed to me that our church does not have a clear understanding of what evangelism is so I will be working on that in the new year.

Transformation/Visioning

We will meet soon to share what they learned and what learned, wrap up with the consultant, and see how we need to move forward. The repercussions of COVID on the congregation are showing up and revealing that we need to regroup on some of our leadership structures and the need to put some of our dreams on hold.

Hobart-Wagner:

RECOMMENDATION/REQUEST TO THE OFFICIAL BOARD

Date: September 1, 2021 From: The Property Team

Re: Proposal to replace sanctuary air-conditioning units

Background: During August, the Property Team had the sanctuary air-conditioning units serviced. It was discovered that one of the units was leaking refrigerant and the other had a compressor piston that was sticking. The technician advised proactively replacing the units since there was no way to estimate how long the units would continue to operate. As far as anyone can recall, the units were originally installed in the early 1990's meaning they have been in use 25-30 years, which may be well beyond their life expectancy.

Team Action:

1. The Property Team secured proposals from three companies to replace the

units: Blue Ridge, McGrady-Perdue and New River. All three submitted proposals.

2. At a meeting on August 31, the team decided to recommend the McGrady-

Perdue proposal for the Amana units to the Board (specs attached).

Cost: \$18,700, itemized as follows:

\$17,500 – units

850 – air purification system

350 – thermostat

\$18,700 - total

Request: Approve the Property Team's recommendation to purchase the Amana units from McGrady-Perdue and for that company to install them. The team also requests permission to spend up to, but not to exceed, \$20,000 in the event that a problem is encountered in the installation process.
