I'm writing this the day before we go on our Congregation Council retreat. I'm really looking forward to it. We're holding this overnight event at the San Pedro Spiritual Development Center in Winter Park. This will be a time when the Council (and a few other leaders not on the Council), will be together, relax, pray and deliberate about Gloria Dei Church, specifically the role of the Council in the life of our Congregation.

Because we don't teach on these important things, many incorrect assumptions can float around.

This isn't a bad time to remind all of us about exactly what a Congregation Council is, and how it functions in the life of the Church. Following is a series of bullet points about Councils and church governance, we can call them "Theses" if you'd like (there's a long Lutheran tradition of such things....).

- The Christian Church is governed by Councils and Shepherds (i.e. pastors and bishops). This exists at every level: Congregation, Synod, national and even the Lutheran World Federation. It also exists in one form or the other in all the other historic streams of the church, Anglican, Reformed, Methodist, Orthodox, and even the Roman.
- Although comparisons between the political and the business world inevitably happen, the Church is NOT a democracy, a monarchy, or a business, but a Communion through Christ in the Spirit with each other. There's a difference!
- Pastors are not hired employees, dictators or CEO's, but Shepherds of the Flock. They're Called Servants of the Word.
- Council meetings are open and public. You can attend. As any board meeting would be, in order to maintain good order, visitors can only have voice at the recognition of the Chair. If you wish to attend, speak to Bill or myself. The meetings are listed on our Calendar.

Please pray for us as we seek the guidance of the Holy Spirit for the mission of Christ at Gloria Dei!

Friday, May 6 at 9:30, Gloria Dei will be hosting Church Women United as we celebrate May Friendship Day/Least Coin. Church Women United will be represented by several local area congregations. May Friendship Day began in 1933 when two women's groups, meeting at separate luncheons, focused on children's health and the children of migrant families. In 1939, the groups merged to become the National Council of Church Women. The organization soon held its first annual observance of the day "to strengthen a growing sense of unity, the joy of Christian fellowship, and the power of Christianity in the day of need." In 1945, the observance officially became Friendship Day, in 1999 Church Women United changed the name to May Friendship Day.

Fellowship of the least Coin is a worldwide ecumenical movement of prayer for peace, justice, and reconciliation initiated in 1956 and celebrated in over 80 countries. Reminiscent of the "widow's mite", "least coins" are given with each prayer, keeping the movement focused on prayer and reconciliation rather than money. Christian women around the world gather to seek fellowship with each other and are reminded to live a reconciled life with others. The combined funds from the least coins are shared as grants to women who want to improve their lives and the lives of those in their communities.

During the summer months, the WELCA Board, Mary/Martha and Ruth Circles will not be meeting. We will resume meetings in September. The Quilters will continue to meet at 9:00 a.m. on the 2nd Tuesday and the 4th Friday of each month at the church.

SOCIAL MINISTRIES COMMITTEE

The Social Ministries Committee met April 20th at the church. Leone has sent a check for \$1,000 to Lutheran World Relief as approved in March. She has also sent in the \$1090 for camp week July 17-22 for Quiana and Julian Menchaca. The committee was delighted to hear that they are very excited to attend camp at Lutheran Outdoor Ministries Campership.

Joe was contacted to see if he could locate shorts for 4 girls at Leesburg Elementary. He was able to locate two pairs each and provide them to the school. No additional funds were needed to accomplish this, due to the generosity of the congregation's individual members.

Pat took a carload of canned foods to Salvation Army. It was donated by Donna Tarnok's community when they discontinued their food bank. She also delivered clothing donated by the congregation for Salvation Army.

The committee voted to give \$500 to LovExtension, a non-profit which benefits the disabled and elderly. The funds will be used to purchase items needed by their clientele. LovExtension is a professional visitation service dedicated to elderly and disabled individuals with limited resources.

The committee also approved a donation of \$500 to Lutheran Immigration and Refugee Services. A unique feature of this organization is that 100% of the donations go toward their programs to help those in need.

A Melon Patch Theater event will be a benefit for Forward Paths on May 1 at 2:00 pm. The play "The Things They Carried" will be performed. Tickets are \$35 for adults and \$15 for veterans and students. Contact Melon Patch for additional information and tickets.

Minutes of the Gloria Dei Congregation Council Thursday, 10 March 2022, 10:30 am

We opened with a Eucharistic service by Pastor Barnett and the Sacrament of Unity.

- I. **Call to Order** The meeting was called to order at 10:30 am by President Bill Birdsall.
- II. **Roll Call:** <u>Present</u>: Pastor Edward Barnett, Bill Birdsall, Craig Carlson, Linda Hide, Arlene Kelly, Crystal Kirkpatrick (excused), Linda Riikonen, Linda Steege, Loraine VanHaecke, Diane Wasser
- III. **Promise** The Covenant Promise was recited by the Council.
- IV. Adoption of Agenda The agenda was reviewed and revised to add item N under Unfinished Business, Advertising, and F under New Business, Rain Gutter. Motion to accept the revised agenda by Arlene, second by Craig. Motion carried.
- V. **Approval of Minutes of Previous Meeting** Minutes of the 10 February 2022 meeting were reviewed. Motion to accept the minutes by Craig, second by Linda Steege. **Motion carried**.
 - **Approval of Minutes of Annual Congregational Meeting** Minutes of the 27 February 2022 annual congregational meeting were reviewed. Motion to accept the minutes by Bill, second by Linda Riikonen. **Motion carried**.
- VI. **Appointment of Officers** The following council members were nominated and elected by a unanimous written ballot: President Bill Birdsall, Vice President Arlene Kelly, Secretary Diane Wasser, Treasurer Linda Hide. Motion to elect the above officers by Linda Steege, second by Craig. **Motion carried**.
- VII. **Correspondence** Bill reported that he received a letter from JHIFM and the quilters requesting to address council on the space allocation. He also received a letter from Bob Glockler of JHIFM regarding the proposed shed.
- VIII. **Pastor's Report** Pastor Barnett commented that the Annual Congregation Meeting on 27 February was the worst annual meeting he's ever experienced. He said that future annual meetings will be run much more orderly. He recognizes that changes are occurring at Gloria Dei; we must develop an understanding of who we are as a congregation, and develop unity and provide solid leadership. The congregation needs to be instructed on the function of the church council in governing the congregation.

Pastor reported that we need two (2) voting members for the Synod meeting in Orlando on 3-5 June 2022.

Pastor reported that we need two (2) conference representatives for the 14 May Pinelands Conference at Rock of Ages. Bill, Arlene, and Loraine volunteered to attend this conference.

IX. Unfinished Business -

- A. Status of New Building for JHIFM, Rejection Letter from JHIFM, and Council Response Bill reported that he met with the JHIFM steering committee and received a response from Bob Glockler stating that JHIFM felt that a new building was unnecessary. Bill prepared a draft reply to Bob Glocker's response. After a very lengthy discussion, it was decided to add a paragraph to Bill's reply requesting a representative from JHIFM to join the retreat in April. Arlene will edit Bill's reply to Bob Glockler.
- B. Update on Space Allocation Study and Meeting with Quilters Bill reported that the solution to make Gloria Dei's ministry better, will not make everyone happy. Bill noted that we have a lack of younger members to carry on our ministries. Bill is waiting on a written response from the quilters on their needs and requirements. Pastor is also requested that a representative from the quilters attend the retreat in April.
- C. Evangelism Committee Update Bill reported that the committee met on 8 March 2022. He reported that the committee had a conversation on change and how evangelism can play a part in helping our congregation prepare for the future and change.
- D. Roof Repair Update Bill reported that the cost to repair the roof is \$13,500. Bill is waiting for the contract from Eustis Roofing.
- E. Annual Meeting Review Covered in Pastor's Report above.
- F. Columbarium Update Linda Hide suggested we update the fee to \$2,000 per niche. Motion to update the niche fee to \$2,000 by Craig, second by Arlene. **Motion carried**. Bill will have Mary Beth revise the columbarium contract.
- G. Council Retreat Update Pastor reported he is still searching for additional representatives to attend.

- H. Building Use Fees Arlene reported that she had discussions with various churches regarding fees for outside groups. The average fee was \$25/week, with no charge for members of the congregation. Loraine and Craig volunteered to research other churches.
- I. Financial Advisor Update Pastor reported there was nothing to report.
- J. Yard Sale 1 April 2022 Bill reported that we need two (2) signs posted a week before. He will also announce at church the week before. The furniture and folding chairs from the fellowship hall will be sold at the yard sale.
- K. Media Production and IT Specialist Irv and Sue Johnson cannot continue in this position. We need to hire a specialist.
- L. Covid 19 Discussion Pastor reported that there is a sign on the door stating "Wearing masks is welcome."
- M. Shooter Awareness and Response Update Craig reported that the Leesburg Police will respond to any incidents at the church. Leesburg Police will contact Craig regarding a program to revise our security.
- N. Advertising Arlene will create an ad for the yard sale. Craig suggested advertising in Coffee News and What's Happening.

X. New Business –

- A. Handling of Repasts Costs Pastor suggested giving bereaved families suggested menu choices with costs. If families are unable to pay, Gloria Dei will cover the costs. Arlene volunteered to write up menu suggestions and costs.
- B. Web Page and Webmaster We need to hire a webmaster. Bill will contact Irv Johnson for proposal.
- C. Discuss Officers and Council Member Responsibilities Pastor reported that this will be discussed at the retreat in April.
- D. Repair Leaking Downspout/North Side of Building Craig will handle this.
- E. Replace Plants Killed by Frost Bill reported that several plants were destroyed by the frost. It will cost approximately \$300-350 to replace these plants. Motion to replace plants by Bill, second by Craig. **Motion carried**. Bob will replace plants.

XI. Reports -

- A. Pastor Pastor Barnett reported on numerous items throughout the meeting as noted in the minutes.
- B. President Bill reported on numerous items throughout the meeting as noted in the minutes, as well as emailed his report prior to the meeting.
- C. Vice President Arlene emailed her report prior to the meeting.
- D. Treasurer Linda Hide emailed the financials prior to the meeting. Linda reported that the giving in February was about \$16,000. In January, the stock market investments dropped about \$19,000, but these investments are now increasing. Linda reported that the Endowment Committee has requested she move the funds in account 1109 ELCA Endowments (\$33,492) to a Thrivent account. Linda will move these funds.
