Business Meeting Saturday, April, 28, 2018

"Peace be with you".

It was the greeting that Jesus used when he visited the Apostles in the upper room after the Resurrection. A greeting he used many times, but the one he used when the group was the most vulnerable and frightened. His wish for them, according to many Catholic Bible Scholars was the kind of peace that comes from inner knowledge and strength, the kind of peace that can only come from loving your God with all your heart, mind and soul. From loving your neighbor as yourself and from helping the least of your brothers. That's the kind of inner peace that comes from using the gifts the Holy Spirit gave them at Pentecost, and the gifts that were given to us at our Confirmation.

The Knights of Columbus use those gifts to strengthen our Parishes, our Communities, our State and our Nation through our principles of Charity, Unity, Fraternity and Patriotism. The inner peace that comes when we put our Faith in to Action.

It is my honor to report to you today that South Carolina, with its now 64 councils, has had a great year as we used those gifts to continue to make a difference in the areas of Service to our Churches, our Communities, our Families, our Youth and our commitment to life in all its stages.

This is only accomplished through the leadership and dedication of all the Grand Knights, council officers, and directors who are promoting the Order's principles of Charity, Unity, Fraternity, and Patriotism. All 16 District Deputies must be commended for their leadership and hard work. We, the State Officers and Committee Directors thank each of you for the South Carolina Jurisdiction's accomplishments and successes. It has truly been a year blessed by St. Joseph the first leader of the Domestic Church.

CHARITY

Charity programs are the foundation of the Knights of Columbus at the Council, State and Supreme level. At the Supreme Convention in August, we will receive the report of the staggering figures of what all 74 jurisdictions of the Knights of Columbus has contributed in dollars and man hours. On the State level, this year, our Charity Drive raised over \$55,800.00 for support of our diocese and many other worthwhile organizations and individuals. Again, this year, no one that applied for charity donations was turned away.

In December the State Council spearheaded a drive in which Our Councils provided cookies, nativity snow globes and coloring/activity books so the 35 Children at the Felician Center in Kingstree would have gift bags to open at Christmas. These as well as cash donations from Knights around the state made the Felician Center a Joyful place in the center of the poorest county in South Carolina. In the Spring the State Council sponsored another drive in which Our Councils provided cereal and

socks to get the girls and boys through the Summer. And, throughout the year, each time we get together the Felician Center is blessed with food, clothing and monetary donations. State support of citizens with intellectual disabilities through the Columbus HOPE Foundation is another one of the charity programs that we proudly support. To date, our councils have supported the HOPE Foundation with over \$363,000 and more donations set to come in.

UNITY

Based on the nominations for this year's Program Awards and ICC reports, councils who achieved the greatest successes were the councils where the members united within themselves for a notable charitable cause.

An area where this was demonstrated was Greenville where Council Director David Abbott, spearheaded a Social Knights Committee that has so far been responsible for six council socials, two road trips, four new Knights and the retention of at least one brother that was four years behind in his dues. This program so far has raised over \$600 for the Greenville Ultrasound Initiative. Dave's Motto is "increases in membership is always a benefit". A wise old friend of mine once told me that if I wanted anything done right to ask a busy person to do it. I am proud to announce that with the leadership of Brother Abbott the South Carolina State Bowling tournament will be starting up again this Fall. Please keep September 29 open as we will be kicking off our Coats for Kids program at that tournament.

In Summerville the Knights Council planned, cooked, manned the sausage food tent, provided parking and traffic control, sold raffle tickets, set up and tore down tents and booths at the St. Theresa the Little Flower's Fall Festival, one of the Parishes largest fund raisers.

And in Lexington where living out fraternity means to respect those who have gone before us. A luncheon was held in honor of the Council Charter Members. And the list goes on......

FRATERNITY

Fraternity is exemplified in our aid to fellow Knights who are disabled, hospitalized, or affected by the storms that have wreaked havoc on our state the past few years. With the development of the South Carolina State Disaster policy, the State Council this year, has stepped up its commitment to support the local councils. Disaster relief funds have provided over \$14,000 in aid to storm and fire damaged council centers and brothers affected by illness, storm and fire damage.

When the Grand Knight of Council 8790 in Marion/Dillon came down with the dreaded MRSA infection in his leg, he was just a few days away from amputation if he didn't come up with the \$3,000 for a Medivac machine to help clear out the infection. Unable to work and without a car, the State Council donated \$1,000 from the State Charity Drive while the councils from around the state came up with the remainder. It will be a long road to recovery, but the machine was a life saver for brother Dave.

Again, this year we reach out to our brother Catholics in the Hispanic and Vietnamese Communities by inviting them to join us. With the leadership of State Advocate Mike Radl, we now have Spanish initiation and formation degree teams that will travel across the state to bring in new brothers wherever they are.

And it was my honor to represent you, the South Carolina Knights, at the Supreme Convention in St. Louis, Missouri August 2017. I was further honored to chair the Supreme Credentials Committee.

Church

The running of the Rose began in 1960 by members of the fourth degree in Monterrey, Mexico, running a real rose from Monterrey to the shrine of Our Lady of Guadalupe. In 1961 the rose was cast of bronze to be run in the same manner; however, the Mexican Knights had other designs and had a "perfect" rose cast of Mexico's most precious commodity, silver. Eventually there were three perfect Silver Roses cast for the run which now starts in Canada and continues through America arriving at the shrine of Our Lady of Guadalupe on her feast day, December 12.

One of these three Roses has made their way through South Carolina for many of those years. Thanks to Church Director and District Deputy Mike Mancari, this year the whirlwind trip was organized from North Carolina through 5 districts and back out to Georgia on its way to the Guadalupe festival.

In honor of the patroness of the Knights of Columbus, on the Sunday before her December 12th feast day, the members of the Father John B. Adair council join with their Hispanic brothers for a mile-long procession, carrying icons of Our Lady of Guadalupe complete with an orchestra in tow on the back of a truck. The goodwill between cultures is immeasurable and the gap is shrinking every year.

Pro-Life

Our Pro-Life Program, led by the State's Pro-Life Couple, Bill and Dee Hooks, continues to be a huge success and continues to grow. Bill and Dee continued the A.C.E. Wings Award (without Apology, without Compromise and without Exception) program by presenting the Wings to 28 applicants around the state, bringing the total number of wings to 404.

On March 17th Council 9184, Prince of Peace held a Monte Carlo night for Birthright of Greenville to purchase Right to Life billboards for the coming year. The council raised over \$15,000 to completely cover the cost of these billboards. The evening ended with enough donations to give Birthright a little extra for their fight against abortion in South Carolina

And speaking of the fight against abortion, with the guidance of our Ultrasound Initiative Couple, Ray and Ingrid Ireland, over the past two years we have been approved or installed 6 new ultrasound machines across the state. This will bring the total number of ultrasound machines in our small state to 18.

A list of accomplishments would not be complete if I failed to mention the 4th Degree Sir Knights in regalia continuing their strong tradition of leading the Stand Up for Life March each January. On the evening before the March, the South Carolina Citizen's for Life sponsor's the "Proudly Pro-life" dinner which was held at Seawell's Banquet Center this year, the keynote speaker was Ryan Bomberger, Author, Emmy® Award-winning Creative Professional and founder of The Radiance Foundation.

Community

The councils of South Carolina have to date donated \$1,559,036.44 and dedicated 379,547 hours of service to their communities. They spend many hours on such projects as Habitat for Humanity, blood drives, road clean up, food for the hungry and the help and support for the intellectual disabled citizens. According to the Independent Sector, an independent foundation that tracks Non-profits, a volunteer hour is now worth \$24.69 that brings the total value of the Knights of Columbus service to South Carolina this year to \$10,994,574.86

Council/Family

Debbie and I have had the opportunity to visit several councils throughout the state. To mention a few of the areas: Marion, Conway, Greenville, Spartanburg, Beaufort, Rock Hill, Columbia and Charleston. We thank the Grand Knights and the council members for their warm welcomes and gracious hospitality.

It was especially enjoyable when these opportunities provided me the honor of presenting them Awards or to join them in celebrating a special occasion.

Like Our Lady of Grace Council 14765 who held a party for brother Fred Rom who celebrated his 105th birthday on April 3 and will celebrate his 65th anniversary as a Knight on May 1.

We were especially honored to be invited to the St. Martin De Pores elementary school's 81st anniversary party where Council 6847 and Assembly 1072 have been benefactors over the past several years.

Tomorrow, at the Annual Awards Breakfast, we will have the opportunity to review and award some of your Councils for their outstanding achievements in serving the Church, Community, Council, Family, Youth and Culture of Life Programs. I want to thank our Program Chairman Paul Burchell, for his hard work in getting the councils to record their involvement in our Service and ICC Programs.

<u>Youth</u>

This year, 95 youth volunteers and councilors came to Charleston from across middle America for this year's HOMEWORKS summer blitz. Many of these teenagers knew very little about the Charleston area or the Catholic Church. Brother Michael Spooner and the Knights of Rev. John J. Egan council stepped up to provide hot meals, a taco night and a departing breakfast for the volunteers while the stayed at the Family Life Center at St. Joseph's church. This gave many of these teens a positive and lasting first impression of the Knights of Columbus.

Summerville council 11910 uses the Youth of the Month Award to unite the parish ministries where they solicit candidates for the award from the various parish directors. The key to the program's success is the partnership between the Knights, the Pastor and the leadership of the Church. The winning citation highlighting the youth's accomplishments is read and presented at Mass in front of the entire congregation.

In Lexington at the Corpus Christi council, youth director, Richard Swain, uses that council's large presence in the CCD program to unite the council, youth, pastor and parish.

Our Scouting programs continue to thrive, despite the current political atmosphere. Scouting under the leadership of State Scouting Director James Weiskircher and the Spiritual guidance of Bishop Robert Guglielmone, are in no danger of losing their Catholic identity:

A few years back Bishop Guglielmone challenged Father Jason Adams, Diocese of Savannah chaplain, Father Matthew Gray, Diocese of Charleston chaplain, and Father Giovannie Nunez, C.R.M. a religious priest of the Adorno Fathers to start the Bishop England Trek. Bishop England Trek is a collaborative effort of the Diocese of Charleston and the Diocese of Savannah. The Trek is patterned after St. George Trek in Philmont New Mexico. It seeks to promote vocations to the priesthood and consecrated life among young scouts.

Due to your generosity through the record year at the State Charity Drive headed by State Treasurer Daniel Barton, we can assure Bishop Guglielmone that the Bishop England Trek will continue to fill our Seminaries for years to come.

South Carolina Knights of Columbus continue to be the largest supporter of the Diocese of Charleston Catholic Committee on Scouting.

We take pride in supporting our youth by providing them with financial support, leadership and guidance in our Catholic Faith.

Vocations

Our Vocations Chairman James Weiskircher in conjunction with the Diocese Vocation Director, Rev. Fr. Mark Good, has our vocation program running extremely well. So well in fact that we will have a record number of men from the Diocese of Charleston in seminaries next year.

<u>Membership</u>

In 1882, Father Michael J. McGivney gathered a small group of parishioners in St. Mary's Church in New Haven, Conn. His purpose was to establish a group of men, united in their Catholic faith and to provide for Catholic families in times of need. This was the beginning of the Knights of Columbus.

Following Fr. McGivney's footsteps and guided by the principles of charity, unity, and fraternity, members of the Knights of Columbus work to overcome the hardships that people face in their parishes and communities. We are a growing organization - nearly 2 million members - and for 136 years have committed to overcome the challenges of the need for food, shelter, warm clothing and financial security, as well as provide aid for widows and orphans in our local communities.

- Today we stand 32nd in the Orders 74 Jurisdictions in the hard-fought Net/Net category of membership and we are just a few members short of the 10,000-member mark.

Also, the South Carolina Knights remain in that elite group of having no suspended councils.

I want to remind you that this year is not over. There is over one month remaining, if you have not, or feel you will not achieve Star Council numbers, do not let that keep you from asking Catholic men to discover a way to enhance their Catholic faith.

The South Carolina Insurance program is doing well; the Boni Agency is dedicated to assisting your council to reach the prestigious Star Council designation. I would like to take this opportunity to acknowledge Larry Thomas, one of the hardest working and most successful Field Agents I have ever known. I was lucky to have served Larry as District Deputy and even luckier to be able to call him friend. I will never be able to repay the personal debt I owe to Larry Thomas and Robert Boni. Larry will be retiring this weekend and joining the most prestigious group of men in history. Larry has earned the title of Grandpa and will be taking this time in his life to stop, smell the roses, and bounce a few grandchildren on his knee.

PATRIOTISM

Our patriotic program in South Carolina continues to be very strong with continued growth under the leadership of our Worthy District Master, Thomas Monahon. The Assemblies and Councils continue their support for the troops overseas and at home.

Our Assemblies throughout the State, with Tom's leadership are revamping the Knights of Columbus Veteran's Administration Volunteer Service Program where they visit the Veterans Hospitals regularly to bring them food, supplies and much needed fellowship.

This year, having successfully wrapped up our involvement with the Knights of Columbus Military Chaplain Scholarship Fund, the State council is showing their Support by sponsoring a wounded warrior to Lourdes. At the Mid-winter meeting in February, we learned that our State Chaplain, Fr. Higgins will be named the Supreme Chaplain to this program, so with the help of Daniel Barton, State Treasurer and input from the entire council, we have decided to send one wounded warrior from South Carolina to Lourdes every year,

I would be remiss if I didn't include one more item under the title of Fraternity. A working relationship that quickly turned into respect, then a respect that turned into a friendship, and a friendship that turned into the kind of love that only brothers can understand. I can stand here and list a small amount of the successes that you and I have had in the past two years, but none of this would have been possible without the support of a strong right hand. Convention Rules by the Committee on Laws and Resolutions

- 1. The State Deputy, prior to opening the convention shall appoint a Board of Tellers (anyone of whom shall be eligible to serve as Election Commissioner). They shall serve as tellers on all division votes; roll call votes; and shall count, examine a record all ballots cast for election of state officers and delegates or alternates to the Supreme Convention.
- 2. All Knighthood members in good standing entitled to be admittance to secession, but only as spectators.
- 3. When a member of the State Council desires to obtain the floor he shall rise, if the floor has been yielded, address the presiding officer by his official title, and upon catching the latter's attention the member shall give his name and his capacity in the State Council.
- 4. A motion regularly moved and seconded must be stated by the chair before a vote is taken.
- 5. A motion may be withdrawn by its sponsor, before the vote, without objection.
- 6. Members may not speak more than once on any question and not more than three (3) minutes; nor may they yield unused time to other members.
- 7. The chair must state every question clearly and, before putting same to a vote, shall say "Are you ready for the Question?"
- 8. Unless a demand is made by a delegate, the "whereas" clause of all resolutions and amendments shall not be read.
- 9. If no objection is made to a resolution or committee recommendation, it is declared adopted unanimously; saying "no objection? Agreed to."
- 10. All resolutions shall have been submitted in conformity with article III, Section 8. All amendments to or affecting the State By-Laws shall be handled in conformity with Article VII.
- 11. When a proposed resolution or amendment to the By-Laws has been disapproved by the committee, a delegate sponsoring the same shall be allowed on the floor, if requested.
- 12. When the PERMANENT ROLL CALL OF DELDGATES (Article III, Section 4) is initiated, the doors of the chamber will be closed. No one will be allowed to leave or enter and only the votes of delegates present in the chamber shall be counted. The State Warden shall assure that only qualified delegates are in the delegate seating area. The doors shall remain closed until voting of State Officers, Supreme Delegates and Alternates, Resolutions and State Council Budget is completed.

- 13. The nomination of State Officers, Delegates and Alternates to the Supreme Convention shall take placed during the convention. Nominating speeches will be allowed if the position is contested. When nominating speeches are allowed they shall be limited to one speech of three (3) minute duration per candidate. Nominations shall not be seconded, nor shall motions closing nominations be entertained. When only one candidate for any office is presented, the chair shall instruct the State Secretary to cast one unanimous ballot of the State Council for such candidate and declaring him duly elected.
- 14. Robert's Rules of Order, as revised, shall govern all matters and or procedures that are not provided in the forgoing rules or the By-Laws of the Knight of Columbus South Carolina State Council or the Charter Constitution Laws of the Knights of Columbus.

STATE SECRETARY'S ANNUAL REPORT May 2017 through April 2018

It is the duty of the State Secretary to keep a true and faithful record of the proceedings of the State Council, causing to be reproduced said record of proceedings, the same to be certified by the State Deputy, and copies thereof shall be furnished to each subordinate Council in the jurisdiction, all State Officers, District Deputies, and all living Past State Deputies, not later than September 15th, following each annual State Council meeting. The expense incident thereto is to be paid out of State Council funds. Within twenty (20) days after the date of adjournment of the State Council Meeting the State Secretary shall furnish to the Supreme Secretary a copy of each resolution adopted by the State Council and which requires consideration or action by the Supreme Council. The State Secretary shall compile and publish an annual State Council Directory, distributing copies of same to all whose names are listed therein not later than September 7th each year. He shall sign all warrants for checks to be drawn by the State Treasurer. The State Secretary, in the absence or inability of the State Deputy, shall execute all of the duties of the State Deputy. The State Secretary shall perform all such other duties as may be prescribed herein or as may be imposed upon him by the State Council or by the State Deputy, who may request that State Secretary be bonded. Membership Director's Report for Fraternal Year 2017-2018 YTD
Worthy State Deputy:
Summary:

This has been a mixed year for Membership in South Carolina. As we have emphasized this year, Membership is about programs and recruiting. Our councils are conducting charitable works in every corner of the jurisdiction. These works that define who we are as Knights of Columbus are strong. The works are many and they make a difference. Unfortunately, our membership intake continues to be substandard. We are currently 41st in the order for new member intake. As of today, we have 358 new members which is 66% of our state goal. I expect us to end around 70% of our intake goal.

A summary of initiatives I have undertaken as the Membership Director are listed below:

1) Attacking the belief that State Membership is all about the Circle of Honor. I have repeatedly engaged the District Deputies and Grand Knights with the belief that Membership has 2 parts: Programs and Recruiting. Our programs or works are what define us as Knights of Columbus. Recruiting eligible catholic gentlemen not only provides a council with many benefits but it allows them to continue and expand their programs. It is through our works as knights that we visibly put our faith into practice.

- 2) I introduced 2 new themes this year to help Grand Knights better understand the importance of recruiting. First is the idea that the Knights of Columbus is a great tower of charity in South Carolina. From the top of the tower shines the Light of Christ via our councils' charitable works and programs. This light shines in every corner of the state. The foundation of this tower is built on recruiting as new members insure we will continue to have the hands, energy, ideas and talent to keep these programs alive and growing. The "Laws of Attrition" is the 2d theme "people move away, people fade away and people pass away". The Laws of Attrition remind our leaders that you constantly need to recruit for the long term health and welfare of your councils as you will lose your core group.
- 3) Promoting council unity throughout the state. I have asked each council to share their successful programs and recruiting ideas with me so the information can be shared around the state. By sharing our councils' success, they help each other with new ideas for programs or ways to improve current programs. The Palmetto Push is a monthly Membership newsletter that I started last year that tells of great programs from around the state, provides helpful information for recruiting and gives reminders to Grand Knights.
- 4) I have given the councils the Top 10 Recruiting Rules (attached) and reviewed each of them. Following these will result in recruiting success. I have also instilled the Golden Rule of recruiting; "Everything a council does is a recruiting opportunity". Supreme used these rules as their 1st "Best Membership Practices" publication shared throughout the order.
- 5) I have updated the state Membership Guidelines. These guidelines provide Grand Knights with practical information, suggestions and standards for planning and executing their council's programs and recruiting efforts.
- 6) I did drop the Palmetto Report due to a lack of reporting by the District Deputies.

- 7) I have helped councils in the state as requested with advice in programs and recruiting. This includes going to state/district/council meetings, phone conversations and e-mails.
- 8) During this year's Awards Breakfast at our state convention, the State Council recognized our top 5 "Fishers of Men" and our 2 top recruiting councils as part of the Membership incentive plan I developed. I have personally recruiting 9 new members and have a Form 100 signed for another new member expected to join in June.
- 9) In March South Carolina went live with the Supreme On-Line Membership Program. We added a State On-Line Membership Director reporting to me. To date, we have had 8 on-line members join. Council11325 recruited our 1st On-Line member to transfer to an actual council. We have another on-line member who is has shown interest in joining Council 9575. This On-Line program provides another tool in connecting men with the order and provides another retention opportunity for those who no longer want to participate in a council.

Overall, Membership in South Carolina is strong. It shows councils that are committed to the principles of the order. Our councils are actively, through their works, defining themselves as Knights of Columbus. We need greater council focus on recruiting so we can continue to sustain our programs. Eligible men are in the churches. With the right focus, our Grand Knights will find ways to inspire qualified catholic gentlemen to join our ranks in order to put their faith into practice. I look forward to the opportunity to continue these initiatives in the new fraternal year!

On behalf of the South Carolina District of the Fourth Degree, I am proud to report on the Patriotic Degree of the Knights of Columbus. The assemblies of the South Carolina are actively fulfilling the goals of the Patriotic Degree which are to 1.) Stand Firm in Support of the Order, 2.) Proudly Serve the Country, 3.) Unwaveringly Support of the Faith, and 4) Honor the Legacy of Knighthood.

Upon my appointment as the SC District Master on September 1, 2016, the District leadership has been focused on a four-point program to 1.) Improve communications, 2.) Increase Patriotic programs, 3.) Increase Exemplification availability, and 4.) Grow the membership.

Improved Communication

In addition to continuing the "Patriots' Corner" in the State Council Palmetto Bulletin, I communicate to every Faithful Navigator and Faithful Comptrollers at least once a month on District programs and issues. I want to recognize SK Keith Kingren, the District Program Director, and the expertise of SK Clemens Thoennes, State Council Information Technology Director, the Fourth Degree section of the State Council website which were totally reworked and updated.

And finally, as District Master I traveled 4,500 miles to install 28 of the 30 Assemblies. My wife and I enjoyed the hospitality of many Assemblies. I enjoyed hearing about your Assemblies programs and discussing recruitment plans.

Increased Patriotic Programs

Under the leadership and personal effort of SK Keith Kingren, working with many of Faithful Navigators, the South Carolina District enjoyed a banner year. Twenty-four (24) of the twenty-eight (28) eligible Assemblies earned the Civic Award. This is more than any other District in the De Soto Province, including those Districts with1-1/2 to 4 times as many Assemblies. In addition, three (3) Assemblies were recognized as STAR Assemblies. We congratulate to 1.) Fr. Henry Tevlin Assembly #2108, Rock Hill, 2.) Mother Teresa Assembly #2655, Lexington, and 3.) Rev. Bernard Lohman Assembly #3065, CSP, Pickens. This year we are on track to have six to 10 Assemblies to achieve STAR status.

Another major program initiative is the revamping of the Knights of Columbus Veterans Administration Volunteer Service (VAVS) program. The VAVS program is dedicated to bringing

direct support to our country's veterans in VA hospitals throughout the state. SK Wayman Johnson is the District VAVS coordinator. Under his leadership, we have three regional VAVS Representatives and \$1900 has been raised to provide support to VA hospitals in South Carolina.

Increase Exemplification Availability

This Fraternal year, two Exemplification have been conducted; one in Charleston, and one in Columbia. A third one is scheduled for May 26, 2018 in Spartanburg. The honorees for these include the Most Rev. Robert E. Guglielmone, Bishop of Charleston and Robert Boni, Knights of Columbus General Agent.

Grow the Membership

The Patriotic Degree is strong in membership in South Carolina with over 27% of the State Council Membership being Fourth Degree members compared to a national average of about 18%. Nevertheless, South Carolina District has grown by 100 new members so far for this Fiscal year. However, there is much room for growth.

The District continues to focus on three areas to increase membership. First, good Programs and good communications. Second, is increasing our exemplification. The third area is the establishment of new Assemblies. Where new Assemblies have been established, we find brother Knights who were unwilling to join an Assembly which met in adjacent towns or parishes were very willing to join the Fourth Degree when there was an Assembly in their parish. More importantly, we find the Fourth Degree better serves the parish and the life of the local Council improves.

Military Chaplains' Fund

I am proud to give a final report on the excellent performance of the District in our support of the Military Chaplains' Fund. When completed, the District had donated over \$27,800 versus our original goal of \$20,000. Thanks to all the Assemblies, Councils, and Knights that contributed.

District Program Donation

I would also be remiss if I did not report on the District Program Donations that 27 of the 30 Assemblies have supported. As District Master, I found the District equipment to be woefully in poor condition or non-existing. With the Assemblies' contribution, some of the District Programmatic needs we have addressed include:

- **Procurement of Exemplification robes** replacing the six robes that were over 65 years old and in extreme disrepair.
- <u>Procurement of South Carolina State Flag</u> Yes, the District did not have a complete set. This includes a stand and finial.
- Procurement of Flag Poles, Holsters, and tote bags The existing flag poles were totally inadequate to be outside for a parade. The district owned no flag holsters, and each stand and finial hand carries.

Supreme Council Representatives

Section 4 of the Charter, Constitution and Laws of the Knights of Columbus states in part, that "The Supreme Council shall be composed of the following members, all of whom must be in good standing:"

"The State Deputy and the last living Past State Deputy of each State Council who is actually residing in the state or Jurisdiction."

"One representative from each State Council for the first two thousand insurance members, and one representative for the first two thousand associate members, and one representative for each additional two thousand insurance members or major part thereof and one representative for each additional two thousand associate members or major part thereof represented in said State Council as shall appear from the records of the Supreme Secretary. However, any state council having an insurance membership of more than 50% of its total membership will be given credit for any excess insurance members over the minimum number necessary to achieve its last insurance delegate. This excess amount of insurance membership will then be applied toward an additional associate member delegate pursuant to the requirements of this section. But no State Council shall be entitled to more than eight elected representatives to the Supreme Council."

Refer to Section 4(b) and (c) of the Charter, Constitution and Laws for assistance in determining the election of Alternates and the filling of vacancies created when an elected representative cannot attend the Supreme Council Meeting.
