### **Business Meeting Saturday, April 23, 2022**

#### **CALL TO ORDER:**

State Deputy, Paul V. Burchell, called the 101<sup>st</sup> Annual State Convention to order at 10:30 A.M. on Saturday, April 23, 2022, at the Landmark Resort in Myrtle Beach, South Carolina.

State Warden, Christopher R. Hilditch verified that all members present were in possession of a current membership card. State Chaplain, Fr. Robert Higgins led the opening prayer and District Master, Michael A. Allen led the Pledge of Allegiance.

District Deputy 7, Dr. Rick Swain was called upon for making a motion. Motion: **“In order to better recognize the achievements of the Councils of South Carolina, and to hear our State Deputy’s State of the Jurisdiction Address, and the remarks of our Supreme Guest, Scott A. O’Connor, I move that the Business Meeting Part 1 be an open session.”** The motion was seconded and unanimously approved.

State Chaplain, Rev. Robert F Higgins offered prayers before breaking for lunch. State Deputy Paul V. Burchell recessed the meeting at 11:21 AM.

**SECOND SESSION: Call to Order**

The meeting was reconvened at 1:03 PM and called to order by State Deputy Paul V. Burchell.

**ADDRESS BY THE GENERAL AGENT:**

Our General Agent, Robert Boni, addressed the State Convention.

**PARLIAMENTARY RULES FOR THE CONVENTION**

Parliamentarian, Richard A. Gabriel, PSD, explained the proper procedure to follow to gain the floor in order to speak or make a presentation. In addition, an extensive explanation was given on protocol and decorum during an election. **Attachment 2**

**PRESENTATION OF CONVENTION MINUTES:**

State Deputy, Paul V. Burchell, called upon Richard Ronde, DD1 to address the State Council for making a motion. The following motion was made: **“As copies of the minutes**

**of the 100<sup>th</sup> State Convention have been published on the State's website, I move to dispense with the reading of the minutes from last year's State Convention and to approve them as published".** The motion was seconded and unanimously approved.

State Deputy Paul V. Burchell called upon William E. Weiss, DD14, to address the State Council for making a motion. The following motion was made: **"I move to waive the reading of all Committee Reports, and that their Annual Reports be included in the published minutes of these proceedings."** The motion was seconded and unanimously approved. **Attachments 7-13**

### **PERMANENT ROLL CALL OF DELEGATES:**

State Secretary, Jeffrey M. Crouch called the Permanent Roll Call of Delegates by calling each District Deputy to report the number of councils, delegates and alternate delegates present from his district. Immediate Past State Deputy Daniel E. Barton also kept a tally of delegates. Final tally count was 74 delegates (67 council delegates & 7 state officers). Forty-three (43) councils were present with delegates.

### **APPOINTMENT OF TELLERS:**

State Deputy Paul V. Burchell appointed Anthony Zammarrelli, DD2 and Tom Armel, DD16 tellers.

Immediate Past State Deputy, Daniel E. Barton, Chairman of the Nominating Committee reported on candidates for State Office for the 2022-2023 year and delegates to the 2022 140th Supreme Convention.

### **ELECTION OF OFFICERS AND REPRESENTATIVES:**

State Deputy, Paul V. Burchell relinquished the chair to State Secretary Jeffrey M. Crouch, for the purpose of conducting the election of State Deputy for the 2022-2023 Fraternal Year. There being no nominations from the Floor, the State Secretary will cast one vote for Paul V. Burchell, who was elected as State Deputy.

State Secretary Jeffrey M. Crouch relinquished the gavel back to State Deputy Paul V. Burchell to proceed with the election of the remaining State Officers.

State Deputy, Paul V. Burchell conducted the election for State Secretary for the 2022-2023 fraternal year. There being no nominations from the Floor, the State Deputy instructed the State Secretary to cast one vote for Jeffrey M. Crouch who was elected as State Secretary.

State Deputy, Paul V. Burchell conducted the election for State Treasurer for the 2022-2023 fraternal year. There being no nominations from the Floor, the State Deputy instructed the State Secretary to cast one vote for Keith A. Kingren, who was elected as State Treasurer.

State Deputy, Paul V. Burchell conducted the election for State Advocate for the 2022-2023 fraternal year. There being no nominations from the Floor, the State Deputy instructed the State Secretary to cast one vote for Timothy W. Kenney, who was elected as State Advocate.

**LOCATION OF 102<sup>nd</sup> STATE CONVENTION:**

State Secretary, Jeffrey M. Crouch announced that the 102<sup>nd</sup> South Carolina State Council Convention will be held at the Embassy Suites – Greystone in Columbia and will be sponsored by District 2, 7 and District 16.

**NEW BUSINESS:**

State Deputy Paul V. Burchell asked if there was any new business to come before this convention?

There being no further business, State Deputy Paul V. Burchell called upon Joe Avampato, DW15, to come to the podium for the purpose of making a motion: **“In order to better recognize the achievements of the Councils of South Carolina, and to celebrate with our families, I move to have tomorrow morning’s Michael Telesco Awards Presentation to be an open session”**. Motion was seconded and passed unanimously.

**South Carolina State Convention Mass**  
**Saturday, April 23, 2022**

The State Convention Mass was held at 5:00 PM. Mass was celebrated by Rev. Robert F. Higgins, concelebrated by Very Reverend Edward W. Fitzgerald, and assisted by Deacon Robert Cox. There were approximately 240 people in attendance.

The Homily discussed purgatory and its relation to Divine Mercy and the need to make Christ a central part of our lives. A necrology was read as part of the Universal Prayers, remembering over 130 Knights who passed away in the last year. A collection of \$1155 was taken and split between the two priests in appreciation for their presence and support.

**South Carolina State Dinner**  
**Saturday, April 23, 2022**

The 101<sup>st</sup> Annual State Convention Banquet was held at 7:00 PM on Saturday, April 23, 2022 at the Landmark Resort in Myrtle Beach, South Carolina.

The banquet was called to order by Master of Ceremonies, Jeffrey M. Crouch, State Secretary. The South Carolina State Council Officers and their guests, Very Reverend Edward Fitzgerald, General Agent Robert Boni and his wife, and Supreme Guest Scott O'Connor were introduced as they entered the banquet room.

The Pledge of Allegiance was then led by District Master, Michael A. Allen.

Rev Robert F. Higgins was called upon to say the opening prayer.

Jeffrey M. Crouch, State Secretary, announced the Councils as they paraded in with their Council banners.

**Supreme Knight, Patrick Kelly:** The video from our Supreme Knight was shown to all Convention delegates and attendees.

Barton, who then addressed the convention. At the conclusion of his remarks, the State Deputy, Paul V. Burchell, and his wife Judy, presented Daniel with gifts of appreciation for his attendance at the State Convention, and presented flowers to his mother who accompanied him.

Next, State Deputy, Paul V. Burchell, introduced the Supreme Guest, Supreme Director, Scott A. O'Connor, PSD, who then addressed the convention. **ATTACHMENT 1****Annual State Deputy's Report  
Fraternal Year 2021-2022**

It is truly my honor to report the South Carolina jurisdiction is experiencing a banner year and I am humbled by the opportunity and privilege to serve as State Deputy. We are indeed fortunate that for the first time in two years we can gather in-person to celebrate our success.

As we began our journey in July, the State Council stated that one of our goals was to make every council successful. We were committed to opening communications at all levels, and I believe we have made significant progress in doing just that. While we've had to make changes in some of the State Council Officer roles, we are still committed to achieving this goal during the remainder of this fraternal year and in those that follow.

The successes we've experienced would not have been possible without the dedication and commitment of our District Deputies, Grand Knights, and council officers – the folks that make it happen.

As we came out of the pandemic, it was obvious that our members were ready to hit the ground running. Their support for their parishes and communities demonstrated to everyone what the Knights of Columbus are all about. Their "Faith in Action" programs no doubt contributed to the highly successful growth in membership the jurisdiction has experienced thus far this fraternal year. In December, Msgr. Andrew K. Gwynn Council 1668 in Greenville brought in the state's 10,000<sup>th</sup> member, achieving a long sought-after goal. I am pleased to report that the state has exceeded our monthly membership goal each month so far this fraternal year and has finished first in the Southeast Region six of those months. I can also proudly report to you that as we gather for our 101<sup>st</sup> State Meeting, we have already exceeded our yearly Circle of Honor membership Goal.

It is not only our members who have contributed to our success. We must thank the spouses and families who have taken an active part in standing by and supporting their "Knights". As Judy and I have had the opportunity to travel around the state to attend several exemplifications, one of the greatest joys we experience is seeing the pride on the faces of family members when their spouse, father, son, or friend is welcomed into the greatest fraternal, family-oriented organization in the world.

We also owe a significant debt of gratitude to our own Bishop Robert Guglielmone for his outstanding support for the Knights of Columbus. His promotional videos and communications with the clergy have made significant contributions to our growth. We look forward to establishing a personal relationship and working closely with our Bishop-elect Jacques Fabre following his ordination next month. We need to pay tribute to our pastors and all our clergy for

their dedication to their ministry and giving us the opportunities to be visible in their parishes.

Yes, this has been an outstanding year for the South Carolina Knights and I want to highlight a few of our many successes.

We expanded our Membership Team to include directors in different areas of the state. Their role was to provide one-on-one interaction directly with the council's membership directors and eliminate the need to go through levels of bureaucracy to get answers or request assistance. This initiative has shown positive results and we are expanding it even further in the new fraternal year.

For the past several years we've had a desire to reach out to the growing Hispanic community - the fastest growing Catholic population in the state. However, we did not have expertise in this area. I am pleased to report that now we do, and we need to recognize two individuals in particular. Jose Jimenez, V.P. of Hispanic and Ethnic Growth for the Knight of Columbus and Dr. Gustavo Valdez, Director of Hispanic Ministry for the Diocese of Charleston who is also a Knight. Dr. Gustavo agreed to serve as our State Hispanic Growth Coordinator.

Jose has visited our state on three different occasions to train individuals on effective recruiting procedures. Dr. Valdez's personal relationships with pastors and community leaders throughout the state gave him the insight to identifying the best candidates for this training. The results have been outstanding. Following the initial round of training in November, a church drive was held at Blessed Trinity Parish in Greer. A total of 28 members of the Hispanic parish community, including the Pastor, became members of Council 12274. Additionally, several other parishioners have become members since.

In January a similar drive was held at St. John of the Cross in Batesburg which resulted in 19 new Knights. Other successful drives have taken place throughout the state, and I am happy to report that we now have trained recruiters in most areas. We are fully confident that this initiative will continue to pay dividends in years to come.

Another area where we can justifiably be proud is our outreach to the many colleges and universities within the state. Through the efforts of our College Council Coordinator, Brother Tim Kenney we have established relationships with most of the college ministries and are helping local councils in their outreach efforts. We are exposing young Catholic men to the Knights of Columbus as well as assisting them in their Focus groups. While we have not yet established a new college council, work is underway to do just that in the coming months. Additionally, progress has been made in re-energizing Citadel Council 6900 which has been dormant for the past few years.

On October 17<sup>th</sup>, we established Blessed Pier Giorgio Frassati Council 17824 in the fast-growing Carolina Forest area of Myrtle Beach. Charter members included new Knights as well as transfers from other councils in the area whose members reside in the Carolina Forest community. In addition, the council was able to recruit several parishioners who were members of out-of-state councils who relocated to South Carolina. The efforts to establish the new council were led by Father David Nerbun and District Deputy Tom O'Donnell.

During the year we've also had to merge a couple of our councils who were struggling to recruit members and stay afloat. Rev. Norman F. Rockwood Council 9161 in Barnwell was located in one of those areas that lost basically all local businesses, and the potential for recruiting new members was extremely limited. In October, the Board of Directors approved their merger with Our Lady of Perpetual Help Council 6891 in Orangeburg.

Another merger took place earlier this month when Fr. Bonaventure Brown Council 9672 in Camden was merged with Monsignor Martin C. Murphy Council 6847 in Northeast Columbia.

As we continue to look for other opportunities to establish new councils, we are considering the needs of the parishes and communities and the potential for growth in the area. We have identified at least three other potential locations that would benefit from having their own council.

The South Carolina Knights continue our promotion of the sanctity of all human life, from conception to natural death. At the start of the fraternal year, Thomas D. Reilley, Sr. Council 10668 in Hilton Head donated an ultrasound Machine to the Pregnancy Center & Clinic in Ridgeland. In September, Mary Queen of Peace Council 9575 assisted in the purchase of an ultrasound machine for St. John's Hospital in Nyamilima, Democratic Republic of Congo.

Our councils were well represented at the annual "Stand up for Life" weekend in January. The Friday evening dinner had the largest turnout in history, and a large percentage of attendees were Knights and family members. Organized by the South Carolina Citizens for Life, the march and rally on Saturday was once again led by the Fourth Degree and, I am pleased to report that the participation of Knights and parishioners was significantly higher than in the past few years.

Our Lady of the Hills Council 6892 organized the celebration of Blessed Michael McGivney's first annual Feast Day on August 13<sup>th</sup> with a Mass celebrated by the Most Reverend Robert E. Guglielmo. The celebration included a parade of banners from across the state and was documented by Supreme who provided a news crew to conduct interviews and film the event.

We continue to reach out to those in need. Our charitable outreach for the past calendar year at the state level included charitable disbursements of \$100,735 and over 3700 man-hours of service. At the council and assembly level, over \$700,000 and almost 450,000 man-hours were devoted to charitable programs. Yes, we are living the vision of Blessed Michael McGivney and showing the world "where there's a need, there's a Knight."

In addition to supporting in-state charities, we also provided \$4,000 in disaster relief funds to our brothers in Tennessee, Louisiana, and Mississippi when floods, hurricanes, and tornadoes devastated areas of their jurisdiction. Most recently we provided funds in support of Supreme's Ukrainian relief efforts.

We can truly be proud of our accomplishments, but our work is not finished. There are still hundreds of men out there who are just waiting to be invited to become part of a group of dedicated Catholic men who demonstrate their values by supporting their families, parishes, and

communities. Thank you for being you!

We look forward to finishing this fraternal year on a high note and keeping that momentum going into the new year. Momentum is a funny thing; you get the ball rolling and it is hard to stop. But to keep it going we need leaders. We need men who are willing to assume leadership positions at the state, district, and council level. We cannot continue to operate with several of our leaders filling two, three or four positions because other folks just want to stay on the sidelines. WE NEED YOU! I know there are men in every council who would be a great asset to the state team – do not wait to be asked! Join us to help serve God’s people and your brother Knights.

It has truly been an honor for me to serve as State Deputy this fraternal year and I thank you for giving me the opportunity.



Convention Rules by the Committee on Laws and Resolutions

1. The State Deputy, prior to opening the convention shall appoint a Board of Tellers (anyone of whom shall be eligible to serve as Election Commissioner). They shall serve as tellers on all division votes; roll call votes; and shall count, examine a record all ballots cast for election of state officers and delegates or alternates to the Supreme Convention.
2. All Knighthood members in good standing entitled to be admittance to secession, but only as spectators.
3. When a member of the State Council desires to obtain the floor he shall rise, if the floor has been yielded, address the presiding officer by his official title, and upon catching the latter's attention the member shall give his name and his capacity in the State Council.
4. A motion regularly moved and seconded must be stated by the chair before a vote is taken.
5. A motion may be withdrawn by its sponsor, before the vote, without objection.
6. Members may not speak more than once on any question and not more than three (3) minutes; nor may they yield unused time to other members.
7. The chair must state every question clearly and, before putting same to a vote, shall say "Are you ready for the Question?"
8. Unless a demand is made by a delegate, the "whereas" clause of all resolutions and amendments shall not be read.
9. If no objection is made to a resolution or committee recommendation, it is declared adopted unanimously; saying "no objection? Agreed to."
10. All resolutions shall have been submitted in conformity with article III, Section 8. All amendments to or affecting the State By-Laws shall be handled in conformity with Article VII.

11. When a proposed resolution or amendment to the By-Laws has been disapproved by the committee, a delegate sponsoring the same shall be allowed on the floor, if requested.
12. When the PERMANENT ROLL CALL OF DELEGATES (Article III, Section 4) is initiated, the doors of the chamber will be closed. No one will be allowed to leave or enter and only the votes of delegates present in the chamber shall be counted. The State Warden shall assure that only qualified delegates are in the delegate seating area. The doors shall remain closed until voting of State Officers, Supreme Delegates and Alternates, Resolutions and State Council Budget is completed.
13. The nomination of State Officers, Delegates and Alternates to the Supreme Convention shall take place during the convention. Nominating speeches will be allowed if the position is contested. When nominating speeches are allowed they shall be limited to one speech of three (3) minute duration per candidate. Nominations shall not be seconded, nor shall motions closing nominations be entertained. When only one candidate for any office is presented, the chair shall instruct the State Secretary to cast one unanimous ballot of the State Council for such candidate and declaring him duly elected.
14. Robert's Rules of Order, as revised, shall govern all matters and or procedures that are not provided in the forgoing rules or the By-Laws of the Knight of Columbus South Carolina State Council or the Charter Constitution Laws of the Knights of Columbus.

The interest was so large, and the Pastor was so determined, Supreme sent a representative back the following weekend to provide more in-depth information and offer an exemplification. I am thrilled to report that among the Knights present for the exemplification, was the Charter Grand Knight, and several Knights from the Council; all of which, were excited to welcome their Hispanic Brothers of the Parish into the Council. My own responsibilities for this weekend, was to ensure the contact information gathered made it to the Council, and to document the lessons learned to later assist other Councils in the State.

My other duties as State Secretary have kept me busy. Among them, most of my time is spent meeting with future convention sites to secure the most reasonable rates for Conventions, issuing vouchers in accordance with the approved budget, scheduling meetings and securing location spaces when needed, and of course planning and executing the State Convention. Membership Director's Report for Fraternal Year 2021-2022 YTD

Worthy State Deputy:

Summary:

This has been a special year for Membership in South Carolina. As we have emphasized this year, Membership is about programs and recruiting. Our councils are conducting charitable works in every corner of the jurisdiction. These works that define who we are as Knights of Columbus are strong. The works are many and they make a difference.

Currently, our membership intake continues to be among the best in the order. We are currently ranked #5 order wide with an intake of over 94% of our goal with a full quarter left in the fraternal year. This is part due to more councils recruiting. We have gone from 30 last year not recruiting 1 new member to 17. This is a 21% improvement.

We have made some great progress from the last few years. We have gone from 23<sup>rd</sup> to 5<sup>th</sup> in the order for new member intake. We have crossed the milestone of over 10,000 members. We have led the entire order with our Hispanic Recruiting Initiative. We have held several Hispanic Membership Drives that have gained over 50 new members in 2 different councils. Our Grand Knights and District Deputies understand the impact of the "Laws of Attrition and what they mean for their councils. I expect us to finish over 110% of our goal and as a top 5 jurisdiction in the order.

A summary of initiatives I have undertaken as the Membership Director are listed below:

- 1) I have repeatedly engaged the District Deputies and Grand Knights with the belief that Membership has 2 parts: Programs and Recruiting. Our programs or works are what define us as Knights of Columbus. Recruiting eligible catholic gentlemen not only provides a council with many benefits but it allows them to continue and expand their programs. It is through our works as knights that we visibly put our faith into practice.





Overall, Membership in South Carolina has greatly improved over this COVID restricted year. It shows councils that are committed to the principles of the order. Our councils are actively, through their works, defining themselves as Knights of Columbus. We will to continue greater council focus on recruiting so we can continue to sustain our programs. Eligible men are in the churches. With the right focus, our Grand Knights will find ways to inspire qualified Catholic gentlemen to join our ranks in order to put their faith into practice. I look forward to the opportunity to continue these initiatives in the new fraternal year!

### Conference of College Knights Annual Report Fraternal Year 2021-2022

The Conference of College Knights is responsible for enriching the relationship between local Councils and Catholic Campus Ministries, and its Chaplains in their area. At the beginning of this fraternal year, our State Deputy was charged by Bishop Guglielmo to expand the State Council's already excellent work with the youth of this diocese, particularly among College Men.

Accepting the Bishop's Charge, a new initiative was developed in the following manner: Create a statewide discussion forum for College Knights to share commonly shared issues, engage in problem solving, and discover new opportunities for them to engage in corporal and spiritual works of mercy at each Catholic Campus Ministry represented. The College Councils Development Committee was renamed as the Conference of College Knights. The Conference collaborates with a Team of 5 Knights to implement this statewide initiative. The Conference sought to work closely with District Deputies and Grand Knights to revitalize local Council-CCM bonds where they exist and to explore New Council and Round Table opportunities where appropriate. Efforts were expected to reach individual Knights and recruit new members in those Colleges and Universities where a Council or Round Table is not feasible.

Institutions that have Councils, Round Tables or just a few individual College Knights – all have a seat at the "SC Conference of College Knights." The Conference will meet quarterly either virtually or in person with the express intent for Knights to collaborate on General Program activities, problem-solve commonly shared opportunities, and to build fraternal bonds. The institutions represented will be recognized by the Supreme Council's "Conference of College Councils," and will be invited to the Annual College Conference in New Haven, Connecticut.

The Supreme Council's Manager of College Councils, Nicholas Holomon and his assistant Christopher Czyzewski, met with Supreme Regional Growth Director David Tebo, State Deputy Paul Burchell, State Secretary Jeffrey Crouch and Chairman Dr. Timothy Kenney virtually in January. We discussed specific Campus Ministries targeted for growth and shared our forthcoming plans to reach College Knights for the remainder of this fraternal year. Everyone left the meeting all on the same page. One result of the meeting was that several boxes of College Knights recruiting material were mailed to RGD Dave Tebo, who delivered them to State Secretary Jeff Crouch in time for the Grand Knight's Mid-Year Meeting in early February for distribution.

The Director of the Diocesan Office of Catholic Campus Ministry was approached in an effort to improve the role of College Knights as the Strong Right Arm of the Chaplains. The Director, Deacon Jerry White, is very interested in the Conference of College Knights building a bridge between the State Council's network of College Knights and the network of Catholic Chaplains

organized through his office. More planning between the Office of CCM and our Conference of College Knights is targeted during the Summer months of 2022. Deacon White stated he is very impressed with all the local Council support throughout the Diocese and wants more involvement by the Knights of Columbus in Catholic Campus Ministries and Newman Centers.

This report focuses on the following eighteen (18) College or University Catholic Ministries addressed this Fraternal Year.

### **Coastal Carolina University, Conway, SC**

The Intent to Establish a Council was sent to Supreme in late Fall 2021. District Deputy Tom O'Donnell, Sr. began working with Fr. David Nerbun in the renovation of the Newman Center long before our current fraternal year began. Tom O'Donnell and brother Knights from host Council Blessed Frassati 17824, also recently formed this fraternal year, along with many other Knights worked to renovate the Newman Center from the foundation up. ***While aggressive recruiting efforts took grip this Winter, a likely formation date for the new University Council will be in Fall 2022.***

### **Clemson University, Clemson, SC**

Clemson University Catholic Campus Ministry supports between 100-120 students. St. Gerard Council 6884 from St. Andrews Parish continues to serve as the host Council for Clemson again this fraternal year. District Deputy Don Thurlow has aided in coordinating the efforts of Deacon John Leininger, Grand Knight Brian Lamb, Deputy Grand Knight Tom Zavertrnik, Brother Bob Brohm and countless other Council members to consistently meet the needs of the Campus Ministry and its Chaplain Father Dan McLellan. Deacon John Leininger, who is a Clemson Professor Emeritus, leads the overall effort with students and the FOCUS staff. St. Gerard Council has hosted monthly dinners for students, numbering between 80-100 student attendees at each gathering. Recruitment material and membership efforts have generated many prospects for Knighthood. ***It is recommended that a University Round Table be established for the 2022-2023 Fraternal Year, with the very real prospect that an Intent to form a New Council could be filed with the Supreme Council in the Fall 2022.***

### **University of South Carolina - Columbia, SC**

St. Joseph Council 12554 greeted Catholic students at the beginning of the academic year with a barbecue cookout with the support of District Deputy Rick Swain. District Deputy Tom Armel met with Campus Chaplain Fr. Rhett Williams about the prospects for establishing a University Council. Interestingly, Fr. Williams joined the Order while a student at the Catholic University of America, joining the University Council 9542. He wants local councils such as Bishop England 724 and St. Joseph 12554 to continue supporting the Campus Ministry with program activities and membership recruitment. However, Fr. Williams wishes to time the development of a new council with the completion of the new church building, likely in the next two years. ***It is recommended that a University Round Table be established for the 2022-2023 Fraternal Year.***

### **University of South Carolina (USC)- Beaufort, Beaufort, SC**

USC-Beaufort Campus Ministry serves about 100 Catholic students. *It is recommended that a University Round Table be established by Michael O Connor Council 5026 for the 2022-2023 Fraternal Year.*

### **University of South Carolina (USC) - Upstate, Spartanburg, SC**

USC- Upstate is served by the Spartanburg Regional Catholic Campus Ministry. USC-Upstate ministers to about 100 Catholic students. *It is recommended that a University Round Table be established by either Fr. Daly Council 6076 or Mary Queen of Peace Council 9575 for the 2022-2023 Fraternal Year.*

### **Wofford College - Spartanburg, SC**

Like USC-Upstate, Wofford College is also served by the Spartanburg Regional Catholic Campus Ministry. Wofford has about 80 Catholic students that attend the College. *It is recommended that a University Round Table be established by either Fr. Daly Council 6076 or Mary Queen of Peace Council 9575 for the 2022-2023 Fraternal Year.*

### **Allen University - Columbia, SC**

Allen University serves about 50 Catholic students and is ministered by St. Martin de Porres Parish. Although few in number, a University Round Table could be established to minister to the charitable needs and causes identified by students. Equally important, these Catholic students under the direction of a host Council and Round Table Coordinator, can benefit from implementing certain State Programs such as the Right to Life and Coats for Kids. *Therefore, it is recommended that a host Council be identified and a University Round Table Coordinator assigned for the 2022-2023 Fraternal Year.*

### **Benedict College - Columbia, SC**

Just as Allen University is served by the St. Martin de Porres Parish, so too is Benedict College. There are approximately 160 Catholic students that attend Benedict College, which makes this a targeted area of service and growth for our Order. *Benedict College is therefore recommended as a College Round Table Campus Ministry location with a host Council to be identified for the 2022-2023 Fraternal Year.*

### **Anderson University - Anderson, SC**

This institution is not listed by the Diocese of Charleston as having a Campus Ministry. Grand Knight John Davis, from Fr. Friend Council 8295, is in the process of personally reaching out to Anderson University, which is a Baptist school. *We are unsure if any Catholics attend the school. If there are, Grand Knight Davis will contact the Conference of College Knights for a next-step decision.*

### **Lander University - Greenwood, SC**

District Deputy Tom Armel had members of Fr. Adair Council 7129 assess the viability of a new University Council or as a Round Table location. COVID-19 definitely made a deleterious impact on the Campus Ministry with Mass attendance dropping to a negligible level. Fr. Timothy Tebault stopped visiting Lander to provide the Sacraments. Our Lady of Lourdes Parish in Greenwood is the Newman Center location for about 150 Lander University students now. ***It is recommended that a University Round Table be established by the host Council, Fr. Adair, 7129 for the 2022-2023 Fraternal Year.***

### **Winthrop University - Rock Hill, SC**

Grand Knight Mark Eddie of Council St Anne-Oratory 6756 and Former District Deputy Ray Howard are in the process of reaching out to Fr. Guzman at the Rock Hill Oratory about forming a University Council. About 250 Catholic students attend Winthrop University. ***At a minimum, a University Round Table can certainly be set up, but the size of this Catholic Student Community warrants a New Council Development approach first, as we draw near to the end of this academic year and forge ahead into the 2022-2023 Fraternal Year.***

### **Francis Marion University - Florence, SC**

Francis Marion University has roughly 100 Catholic students. It is recommended that the Msgr. Charles Wood Council 5194 should establish a Round Table to promote charitable program activities on Campus, such as Pro Life and for Citizens with Mental and Intellectual Disabilities. ***The Francis Marion University Round Table should be established by Msgr Wood Council 5194 for the 2022-2023 Fraternal Year.***

### **Furman University - Greenville, SC**

There are approximately 80 Catholic students which attend Furman University in Greenville, SC. The Newman Center is affiliated with St. Anthony's Catholic Church and Fr. Johnathon Duncan is its Chaplain. This Campus Ministry, although small in number, is very active in a new effort called "Furman Students for Life." Think how more powerful their efforts can be with the Knights of Columbus at their side. No one has done more for the Unborn and saved more children's lives than the Knights of Columbus. ***It is recommended that Msgr. Andrew Gwynn Council 1668 establish a University Round Table for the 2022-2023 Fraternal Year.***

### **Presbyterian College - Clinton, SC**

The Campus Ministry serves approximately 80 Catholic students. These students share in the sacramental life of St. Boniface Catholic Church. In the recent past, several Knights had been recruited into the local council, NJL 15960 in Laurens, SC, only to graduate, leaving only footprints

of their efforts on behalf of the Order. Catholic students can benefit tremendously by working together in common ground areas with Presbyterian students in the promotion of Protecting the Unborn, advancement of programs that support Citizens with Mental and Intellectual Disabilities, Habitat for Humanity, and Coats for Kids. ***It is recommended that a Round Table be established by Council NJL 15960 for the 2022-2023 Fraternal Year.***

### **South Carolina State University - Orangeburg, SC**

Close to 200 Catholic students share in the sacramental life at Holy Trinity Catholic Church in Orangeburg, SC. Deacon Gary Janelle is the Campus Minister. Efforts have been attempted in the past with moderate success. ***Therefore, the Conference of College Knights recommends that Our Lady of Perpetual Help Council 6891 reach out to Deacon Gary Janelle to determine if the foundation exists for a New University Council or whether the Campus Ministry would be better served with a University Round Table for the 2022-2023 Fraternal Year.***

### **College of Charleston - Charleston, SC**

The Campus Ministry at the College of Charleston is served by Fr. Andrew Frymal. Students attend Mass at St. Patrick's Catholic Church. Approximately 500 Catholics attend the school, making the Campus Ministry a prime area for a New College Council. ***It is recommended that Rev. P.N. Lynch Council 704 pursue a New Council Development effort first with Fr. Frymal and Campus Minister Thomas Gregory or the very least, a College Round Table for the 2022-2023 Fraternal Year.***

### **Medical University of South Carolina (MUSC) - Charleston, SC**

The Catholic Student Association at MUSC attracts upwards of 150 students from undergraduate to graduate to medical school. As in the case of the College of Charleston, students attend Mass and receive the sacraments at St. Patrick's Catholic Church. ***Opportunities for Charitable Works of Mercy are too numerous to list here, but it is sufficient to recommend that Rev. P.N. Lynch Council 704 pursue the establishment of a Round Table for the 2022-2023 Fraternal Year. Collaboration with St. Finbar Council 17760 on any program efforts at MUSC should be pursued as well.***

### **The Citadel Military College of South Carolina, Council 6900 (dormant) - Charleston, SC**

During the Fall of 2021, a delegation of Knights from Rev. P.N. Lynch Council 704, Charleston, SC, led by District Deputy Paul Setti and and Former District Deputy James Daugomah, met with Campus Minister Tony Licari. Tony is a transfer member into St. Finbar Council 17760, Charleston, SC. He was new to his position at The Citadel and requested time to better orient himself to Cadets

and the Newman Center. It was agreed to return in Spring 2022. Brother Michael Pio from Council 704 gained Council support for the donation of \$500 to cover the food costs of their Monday dinner gatherings in the Fall. A similar check presentation is planned for April 11, 2022.

The Low-Country District Deputies met to develop a strategy on approaching Council 6900. District Deputies Michael Cousino, Joe Friend, and Paul Setti met in a virtual setting to collaborate efforts. It was determined that Paul Setti would take the lead on any further efforts at the Citadel, with the concurrence of DD Michael Cousino.

Recent discussions with Campus Minister Tony Licari breathe new life into Council 6900 and the real potential to revitalize it into the Active Council status once again. There are about 12 Active Members still on the rolls and a new Financial Secretary must be identified before moving forward. Tony has several membership prospects lined up to join. His building effort focuses on the Fall 2022 semester for a full Revitalization of The Citadel Council 6900 predicated by the assignment of a non-student Financial Secretary. ***It is recommended that Rev. P.N. Lynch Council 704 pursue the establishment of a Round Table for the 2022-2023 Fraternal Year until Council 6900 is returned to an Active Status.***

The Conference expresses its gratitude to the District Deputies, Grand Knights, Past State Deputies, General and Field Agents who worked tirelessly to serve Campus Chaplains, students, and Brother Knights. Special thanks go to State Deputy Paul Burchell and State Secretary Jeffrey Crouch for their guidance and patience, as all of us build together the future of College Knights into the Broader Legacy of Columbianism within the South Carolina State Council Knights of Columbus.

# Presidents Report

## 2022

Individuals with intellectual disabilities have poor health outcomes and are particularly susceptible to COVID 19 infection. Increased health problems in those with intellectual disabilities is caused by several factors; in some cases, the cause of their disability or complications associated with their disability (in particular, difficulties with breathing) may contribute to higher risk of mortality especially from COVID 19. In other cases, social and economic factors are obstacles to receiving the full amount of health care to which they should be entitled. Additionally, obstacles to effective advocacy for this population may contribute to an inability to receive appropriate and effective health care.

During this time of fear, and trauma, the Special Needs Organizations that help this segment of the population are struggling mightily. The pandemic and economic collapse whether real or perceived, constitute a genuine threat. There's no guarantee that the public will receive these services, now or in the future, or that staff members—the face and heart of every organization—will retain their jobs. Everything is uncertain. Everyone is on edge.

**One thing however remains certain. The Knights of Columbus can make the lives of the people with intellectual disabilities much better and add much needed stability to the lives of the disabled and their healthcare workers.** In the weeks and months ahead, these nonprofits will need a reliable source of funding to keep staff on the payroll, to pay rent and utilities, to provide a measure of services during this period of social isolation and simply, to survive. When I ask nonprofit CEOs how they are doing, virtually everyone leads with the word *stressed*.

These are unprecedented times, and we are all learning as we go along. Here's what I learned so far:

The effects of coronavirus on Special Needs Organizations will be most obvious in three closely related areas: demand, workforce, and financial viability.

### **Demand for services**

One of the first surveys conducted among nonprofits on the impact of coronavirus suggested that 43% expected demand for their services to rise. Many have had to close, while the rest are expected to play an increased vital role in achieving the goal of taking care of the intellectually disabled, and supporting them in temporary accommodations.

### **Staff and volunteers**

The ability of these nonprofits to respond to this demand will be affected by the most obvious Human Resource risk in a pandemic: that staff will get sick or have to self-isolate following government guidance.

Volunteers, a crucial part of the sector, are affected, too, those aged 65-74 are more likely to volunteer than any other age group. They have been more seriously affected by the virus, and more likely to be self-isolating.

### **Funding**

Americans donated over \$470 billion to charities last year. Around a quarter of this was given via the secure direct deposit route. The lockdown and its residual will have a much greater effect on ad hoc cash donations like the Tootsie Roll® campaign, once a very popular form of giving, however due to the new regulations and social norms is declining at an alarming rate. The same is true for all public events

Funding from charitable agencies and fraternities like the Knights of Columbus, must and will become more vigorous to make life better for the most vulnerable of our citizens.

### **Calls for more help**

Without additional action from local councils, many in this sector claim they will be prevented from meeting the increased demand, or even go out of business altogether. Small nonprofits make up 96% of the sector and these compact groups of local organizations face an uncertain future. But even many well-known charities are already taking drastic measures to conserve funds, like furloughing staff members, and curtailing services.

The silver lining to this scenario is that the Columbus HOPE Foundation is still standing after almost two years of being handicapped by a near crippling pandemic. Last year you raised \$164,080.00 or 48% of our goal of \$343,463. 10 councils achieved 100% or greater with 4 councils hitting an incredible 200%.

In conclusion, whether dealing with coronavirus proves to be a marathon or a sprint, tens of thousands of Intellectually and developmentally disabled South Carolina residents depend on what you do at your local community.

### *New Assemblies*

---

Why new assemblies? The reasons haven't changed over the past years. To give men the opportunity to be involved with the work of patriotism and Catholic citizenship in their local area. A local assembly means less travel time for Sir Knights which has proven to increase participation at meetings, functions, and honor guards. A new assembly can be formed with as few as thirty members with six of them new members. South Carolina has 64 Councils and only 30 Assemblies so there are still opportunities to form additional assemblies. We have several areas that have enough growth to sustain Assemblies. ### *Serving Those Who Served*

---

The Fourth Degree Knights are a volunteer partner with the Veterans Affairs Medical Facilities in Augusta, Georgia, Charleston, and Columbia, and now Myrtle Beach. Established in 1946, the Veterans Affairs Voluntary Service (VAVS) has become the largest volunteer program in the Federal Government. Our new VAVS chairman, Arthur Sotak will be filling us in on this program shortly. If you are interested in serving as a representative, please contact Arthur, we need all the help we can get.

### *Military Chaplains Fund*

---

I want to stress the fact that the fourth degree has not been called upon by Supreme to continue funding the Military Chaplains Scholarship Fund. I spoke briefly at the Mid-Winter meeting in Columbia about listening to Archbishop Broglio on the Catholic Channel on my way to work one morning in January. His story is one of desperation, and one that has recently taken on more urgency which may be escalating to what scale only God knows. ### *Honor Guards*

---

Let me remind all, that honor guards are to be directed by the Color Corp Commander in accordance with the wishes of the Bishop or pastor. When two or more Assemblies are called to the same event, the Regional Marshall takes the helm, and when two or more regions are called upon, the District Marshall will preside.

Without exception, honors by the Honor Guard shall be offered to deceased Sir Knights, their immediate family members, Council members and to their immediate family members provided a request is made. It must be distinctly understood that the wishes of the family of the deceased member are paramount.

**Keep in mind that no matter the wishes of the family or last request by a brother Knight, under no circumstances will the old regalia be used in any ceremony at any time for any reason.**

---

### *Star Assembly Award*

---

There are several recognition awards available to assemblies that are engaged in programs supporting the vision and goals of the 4th degree. I encourage each assembly to work toward the Civic Award and the "To Be a Patriot" award. The Civic Award is a tribute to the spirit of patriotism and national pride exemplified by the assembly's program of activities. To qualify, the assembly must conduct and report at least four varied patriotic programs held within the fraternal year. The "To Be a Patriot" Award annually recognizes the three best patriotic programs conducted by Fourth Degree Assemblies each fraternal year. The assembly must submit a report on their single best patriotic activity on form #TBP-2 and send it directly to the District Program Director. All the assemblies that have achieved their membership goal have been contacted and requested this application. I will accept these applications through the end of May.

The Supreme Council now awards the "Star Assembly Award" which includes the above two distinctions and several other items. I encourage assembly leadership to review the

requirements and make them part of your yearly goals. You will be hearing from Keith Kingren as the deadline approaches as I believe more assemblies qualify than have applied.

---

### *Installation of Officers*

---

Laws and rules of the Fourth Degree require that assembly officers be installed no later than the first regular meeting in October. Send your request and several potential dates to myself (districtmastersc@gmail.com) so that I can schedule myself or a representative be present. I will make as many as I can but will need to rely on the Assistants to the Master to help. It works out well if you can combine your installation with other area assemblies. It is nice if you have a social with wives and families invited. **Fourth Degree uniforms, Tuxedos or dark suits should be worn.**

---

Please be timely in your submission of assembly forms. NOTE that all copies of forms indicating they be sent to District Master should be mailed to:

PLEASE submit your Report of Officers Chosen as soon as you can. This allows us to get the State Directory updated in a timely manner and gives the Supreme Office accurate names and addresses for them to mail their information.

This form needs to be submitted each year – even if the officers remain the same.

A key reminder, each assembly MUST complete an IRS Form 990 and to send a copy to the District Master. **Don't put this off.** Failure to comply can be an expensive oversight.

### COUNCIL RETENTION AND REACTIVATION ANNUAL REPORT FRATERNAL YEAR 2021 - 2022

The purpose of the Council Retention and Reactivation Committee is to work with District Deputies to have active and thriving councils, to assist in revitalizing activities to those councils that waning, and to reactivate activities in locations where councils have become inactive. This report covers activities for this fraternal year.

#### **Merger of Rev. Norman F. Rockwood Council 9161 of Barnwell, SC and Our Lady of Perpetual Help Council 6891 of Orangeburg, SC.**

Council 9161 in Barnwell, SC, and supports parishes in Barnwell and Springfield. Barnwell county is an extremely rural area with diminishing industry over the past two decades. Likewise, the growth of the parishes is stagnate contributing significantly to the decline in membership in Council 9161. The eight avid Knights in Council 9161 can no longer maintain the council. After due effort, it was decided to merger Council 9161 with Council 6891 in Orangeburg, SC and to establish a roundtable in Barnwell/Springfield. The merger was approved by the Board of Directors in November 2021.

#### **Reactivation and Retention of Fr. Bonaventure Brown Council 9672 of Camden, SC and subsequent Merger with Msgr. Martin C. Murphy 6847 of Northeast Columbia, SC.**

Council 9672 saw a decline in membership through the late 2010's. Finally, in 2019, the council voted to fold and subsequently were suspended. Since then, about seven members transferred to councils located 15-20 miles away. This has left a suspended council of approximately forty-five (45) members, including eight (8) honorary Life members.

In the October of 2021, State Deputy Paul Burchell ask me to explore the revitalization of Council 9672. I met with Fr. John M. Zimmerman over lunch and spent two hours with him as we discussed why the council folded, why the lack of activities, and why the membership complacency. I found Fr. Zimmerman to be a dedicated supporter of the Knights of Columbus but somewhat personally offended that the council folded within a year after he was assigned to the parish. While he would welcome any activities, including the establishment of a roundtable, he was pessimistic of any interest, I was able to get Fr. Zimmerman to fill out a Form 4, and was able to transfer him to the Council in Blythewood, SC, per his request.

Working with FDD/PGK Mike Williams, we initiated an attempt to start a roundtable associated with the Msgr. Martin C. Murphy Council 6847, in Northeast Columbia, SC.- the council that five (5) Camden Knights had transferred to. FDD Williams made e-mail contacts with all members, and I hand wrote invitation to the membership to meet with Fr. Zimmerman, Mike Williams, and myself at Our Lady of Perpetual Help Catholic Church. These contacts invited the spouses and noted that food would be available. Of the forty-five (45) members, less than ten (10) responded - all declining the invitation to meet. At our meeting, only (3) Knights attended. While the needs of the parish and a Round Table were discussed, no interest was shown. In total, I traveled over 400 miles, and invested approximately \$100 to provide an active Knights of Columbus presence at Our Lady of Perpetual Help Catholic Church in Camden, SC.



Reactivation of the Fr. Bonaventure Brown Council 9672 is currently not viable and doubtful for many years. Per discussions with State Deputy Paul Burchell, we should proceed with moving the members of the suspended Council 9672 into the Affiliated Membership Initiative.

In February, members of Council 9672 were again contacted by mail asking them to transfer to Council 6847. The letters were signed and mailed by the State Deputy. Two opted to continue their membership as active Knights by transferring to Council 6847. The remaining forty-two (42) members were proposed for the Affiliate Membership Initiative (AMI) in mid-March.

Concurrently, actions were taken to merge Council 9672 with Council 6847. Council 6847 passed a resolution to merge with Council 9672 at their February meeting. On March 7, the State Deputy wrote a recommendation to Supreme recommending the two councils be merged. The recommendation was forwarded to the Board of Directors which will meet in April 2022.

**Reactivation and Retention at Fr. William G. McKinney, Jr. Council 14892 of Loris.**

Upon the request for support from the District Deputy Thomas W. O'Donnell, Sr, State Deputy wrote a letter to the membership of the Fr William G Kinney Jr Council 14892 of Loris, SC, inviting them to meet with him. The meeting was held at Resurrection Missionary Catholic Church in Loris. Nine (9) members showed. The members expressed a commitment to have the council succeed and were committed to have a cooperative Anglo/Hispanic Council. A follow up meeting was scheduled between English and Hispanic mass.

**Reactivation and Retention at Rev. Scott Buchanan Council 15223 of Manning/Santee.**

Upon the request for support from the District Deputy Dr. Richard W. Swain, State Deputy wrote a letter to the membership of the Rev Scott Buchanan Council 15223 of Manning/Santee, SC, inviting them to meet with him. The meeting was held at the St. Mary Mission in Summerton, SC. A big issue for this council is the 25 miles between the Manning and Santee. Seven (7) members from Santee and one (1) from Manning attended as well as the Grand Knight from Our Lady of Perpetual Help Council 6891 of Orangeburg. The members from Santee expressed a desire to merge with the Orangeburg and the forming of a roundtable in Santee. The Council is cleaning up their roster and participating in the AMI. A follow meeting with the members of Manning area is planned. Manning is only 20 miles from Sumter, SC vs. 50 miles from Orangeburg. If the Council is to merge with Orangeburg, it is more logical to move the Manning membership to the Sumter Council

We have performed the procedures listed below, which were agreed to by management of Knights of Columbus South Carolina State Council (the State Council) solely to assist you in evaluating the internal control of the State Council. This agreed-upon procedure engagement, as stated in our engagement letter dated September 21, 2021, was conducted in accordance with attestation standards established by the American Institute of Certified Public Accountants. The sufficiency of these procedures is the sole responsibility of the parties specified in this report. Consequently, we make no representation regarding the sufficiency of the procedures described below either for the purpose for which this report has been requested or for any other purpose.

The procedures and the associated findings are as follows:

- 1. Cash accounts (checking, savings, and certificates of deposit):**
  - a. Obtain a reconciliation of the State Council's bank account(s) to its general accounts(s) as of June 30, 2021. Obtain confirmation(s) from the bank(s) for all account(s) as of June 30, 2021 and agree the confirmed balance to the amount shown on the bank reconciliation maintained by the State Council. Trace deposits in transit to the subsequent bank statement (obtained in Step B) and document the number of days required for each transaction to clear. Review the propriety of outstanding checks with particular emphasis on old items (greater than 60 days old). Scan the bank reconciliation for reasonableness and trace any unusual or questionable items to supporting documentation.**

All supporting documentation was available and agreed to confirmation obtained. No significant outstanding checks or deposits in transit noted. The following checks were greater than 60 days old and were noted to be duplicate transactions and/or transactions that never cleared the bank:

1. 7/19/2019 – ABC Trophies, Inc. – \$24.61
2. 2/20/2020 – Best Western – \$299.04
3. 3/15/2021 – Sullivan's Metropolitan – \$277.63
4. 3/17/2021 – Residence Inn by Marriott – \$794.15

- b. Obtain the State Council's original bank statement for the month following the fiscal year ended June 30, 2021. Review the bank statement for reasonableness and trace any unusual or questionable items to supporting documentation. Agree the beginning balance on the subsequent bank statement to the audit confirmation obtained in Step A.**

No unusual or question items were noted. All bank statements for the month following year-end agreed to the audit confirmation obtained in Step A.

- 2. Investments, Money Market Accounts, and Marketable Securities – Trace amounts reported as of June 30, 2021 to broker statements received from financial institutions, brokers, or other third parties.**

Cash procedures above were applied to the money market accounts. All supporting documentation was available and amounts reported agreed to the statements provided with no exceptions noted.

The Council uses the modified cash basis method of accounting and therefore does not record accounts receivable. Under the modified cash basis method, the State Council records revenue as it is received.

- 4. Notes Receivable – Trace amounts reported as of June 30, 2021 to applicable amortization schedules or other supporting documentation.**

The Council had no notes receivable as of June 30, 2021.

- 5. Property and Equipment – Trace the amounts as reported on the State Council records as of June 30, 2021 to detailed lists or other supporting documentation. Review the documentation for reasonableness and inquire as to the propriety of items that appear unusual or questionable.**

The Council represents it has no property and equipment.

- 6. Other Assets/Prepaid Expense – Trace the amounts as reported on the State Council records as of June 30, 2021 to supporting documentation.**

The Council had no prepaid assets as of June 30, 2021.

- 7. Accounts Payable – Trace the amounts as reported on the State Council records as of June 30, 2021 to a detailed listing of accounts payable by vendor. Examine the supporting documentation for all items over \$1,000.**

The Council uses the modified cash basis method of accounting and therefore does not record accounts payable. Under the modified cash basis method, the State Council records expenses as they are paid.

- 8. Other Liabilities – Trace the amounts as reported on the State Council records as of June 30, 2021 to supporting documentation.**

The Council had no other liabilities as of June 30, 2021.

- 9. Inter-entity Loans – Trace the amounts as reported on the State Council records as of June 30, 2021 to supporting documentation. Reconcile the balance to records maintained by the related entity.**

The Council represents that there were no inter-entity loans as of June 30, 2021.

- 10. Obtain a list of any disbursements paid to members of the State Council's governing body during the fiscal year ended June 30, 2021 and vouch the disbursement to underlying supporting documentation.**

All supporting documentation was available and agreed to disbursement amounts with no exceptions noted.

- 11. Scan cash disbursement ledgers and receipts ledgers for the fiscal year ended June 30, 2021 and select any unusual or questionable items to trace to supporting documentation (unusual items would include negative cash receipts or disbursements greater than \$500 or checks to unusual vendors).**

No unusual or questionable items noted.

- 12. Compare to supporting documentation (award letters, check copy, bank deposits, etc.) any material contributions received during the fiscal year ended June 30, 2021.**

All supporting documentation was available and agreed with no exceptions noted.

- 13. Prepare analytical review procedures to test revenue and expenses for the fiscal year ended June 30, 2021 by comparing current year amounts to prior year amounts noting any large variances (dollar or percentage). Inquire as to the reasonableness of any large variances and review documentation, if deemed necessary.**

All variances were deemed reasonable with no exceptions noted.

- 14. If the State Council sponsors and conducts a raffle during the fiscal year ended June 30, 2021, determine that the proper permits or licenses were obtained as required by local or state laws.**

The State Council holds an annual Charity Ball and attendees' tickets are used to select cash prize winners. Under South Carolina Code of Laws 33-57-120(A), only qualified nonprofit organizations are eligible to conduct raffles. In order to conduct a raffle, a non-profit organization must file an annual raffle registration form with the Division of Public Charities. Knights of Columbus South Carolina State Council completed the registration renewal process for the fiscal year ended June 30, 2021.

**15. Obtain a standard management representation letter form the individual maintaining the records and the appropriate member of the State Council accepting the report.**

Signed management representation letter was obtained prior to issuing final report of agreed-upon procedures.

**16. Based upon procedures performed, if additional procedures are deemed appropriate, please contact Supreme Council for approval.**

No additional procedures were deemed necessary.

We were not engaged to and did not conduct an examination, the objective of which would be the expression of an opinion on the internal control of the Knights of Columbus South Carolina State Council. Accordingly, we do not express such an opinion. Had we performed additional procedures, other matters might have come to our attention that would have been reported to you.

Council 6900: The Citadel Council 6900 has been designated as inactive. The status of this College Council and its membership has not changed. A recent transfer to the State Council from another state and former DD should prove instrumental in reenergizing the Citadel Council and developing other State College and University Councils, possibly through Round Tables and other initiatives.

Council 6726: A very consistent performer and strong membership growth. The initially installed Grand Knight from Council 6726 found it necessary to step down for medical reasons. A new Grand Knight was elected and installed and has done a good job despite lack of experience. He does have adequate support from the Trustees and previous leadership and has been nominated for another fraternal year. The Financial Secretary has received transfer orders and will be leaving the area soon after the fraternal year. A new Financial Secretary will need to be appointed. My understanding is a former Grand Knight has volunteered and is being considered.

Council 11471: The Council has performed well but in moderation. My opinion is the Grand Knight has been in the position for almost five years and the Council needs to appoint a new Grand Knight. Growth of the Council is being stifled. The Council has brought in several Hispanic members who seem to have a great deal of energy. The Hispanic Recruitment training appears to have energized the community and I envision a large and active growth from this community. They tend to think and operate outside the box, but continue to focus primarily on their local Parish and it’s needs.

Council 11991: The Council has consistently performed above the norm. They most strongly adhere to the Faith in Action model, and have completed many of the program elements. The current Grand Knight will be stepping down after one year in office, and a long-time member has indicated his interest in the position. The Brother Knight is a retired senior military officer who is heavily involved in the Parish Council, RCIA, Youth Ministry, Choir and other Parish ministries. The Council has been able to draw greater interest in the large Spanish community and is using a newly reestablished Round Table to advantage.

I was invited to all of the Councils' meetings, socials and work opportunities and was able to attend many. The hospitality extended to me and the encouragement and friendship they offered was greatly appreciated.

Overall, through the challenges of this responsibility in view of the restrictions imposed by the Covid-19 pandemic and several procedural changes imposed by Supreme Council, the year was very rewarding. Each Council is strong in at least some of the Faith in Action areas, and remains supportive in others. I am most proud that the three active Councils are all poised to potentially earn STAR Council status. This would be the second time that District 13 could and should earn STAR District status thanks to the innovative thinking and dedication by each of the Councils.

I regret that for family, personal and health reasons it will be necessary for me to step down as District Deputy at the end of this Fraternal Year (2021-2022). I am actively pursuing my relief whom I hope to identify soon in order to prepare.

**Supreme Council Representatives**

Section 4 of the Charter, Constitution and Laws of the Knights of Columbus states in part, that "The Supreme Council shall be composed of the following members, all of whom must be in good standing:"

"The State Deputy and the last living Past State Deputy of each State Council who is actually residing in the state or Jurisdiction."

"One representative from each State Council for the first two thousand insurance members, and one representative for the first two thousand associate members, and one representative for each additional two thousand insurance members or major part thereof and one representative for each additional two thousand associate members or major part thereof represented in said State Council as shall appear from the records of the Supreme Secretary. However, any state council having an insurance membership of more than 50% of its total membership will be given credit for any excess insurance members over the minimum number necessary to achieve its last insurance delegate. This excess amount of insurance membership will then be applied toward an additional associate member delegate pursuant to the requirements of this section. But no State Council shall be entitled to more than eight elected representatives to the Supreme Council."

Refer to Section 4(b) and (c) of the Charter, Constitution and Laws for assistance in determining the election of Alternates and the filling of vacancies created when an elected representative can not attend the Supreme Council Meeting.
