Circle of Love made 4 trips in 2022: 2 to Guatemala, 1 to South Africa and 1 to Moldavia and Ukraine. 1,221 patients were seen, 4,207 free perscriptions were filled. 325 people made professions of faith in Jesus. In Circle of Love Rockford, 11,236 people received prayer and 384 made professions for faith. 50 men are receiving chaplain visits regularly at the Winnebago County Jail. Thousands of articles of free clothing have been given. Since inception, there have been 126 medical mission trips conducted with 18,722 patients treated, 30,982 professions of faith and 809,673 free perscriptions.

Pastors and missionaries in Thailand, Laos, South Africa, Guatemala and Bangladesh were able to continue in ministry because of the financial support provided by Circle of Love. We also provided financial support for students in Laos, Guatemala, South Africa and Bangladesh.

Effects of the Covid-19 pandemic lingered into 2022 affecting unemployment and other factors. Circle of Love continued to provide support for feeding individuals and families with food insecurity in Guatemala, South Africa, and Laos. Financial support was also provided for Christians persecuted for their faith in Laos and continued support for widows in Laos. Bibles were given in South Africa and Guatemala. Handmade quilts and reading glasses were given in South Africa and Guatemala.
