PROGRAM INFORMATION

Viridis Graduate Institute is a nonprofit DISTANCE EDUCATION PROVIDER. All educational offerings are delivered in weekly synchronous real time classes through ZOOM technology, where students and instructors meet in a live interactive classroom.

TERMS OF ENROLLMENT AGREEMENT

Viridis Graduate Institute follows a quarter system. Termination Date of Agreement. The term of this agreement is thirty-six (36) months from the date of the contract acceptance as indicated by the institutional signature and date.

STATEMENT OF OBLIGATION

Viridis Graduate Institute is a private 501(c) 3 nonprofit Institute operating under the laws of the State of California. Viridis Graduate Institute will provide the student curriculum and instruction in English and with every effort toward reasonable care and skill. Viridis Graduate Institute will make all reasonable efforts to deliver the program as described in the Institute's Catalog, however, the Institute must manage its resources efficiently and shall be entitled: to alter the timetable, number of classes, and method of delivery, provided such alterations are reasonable; to make reasonable variations to the content and syllabi of the program; Viridis Graduate Institute will make available to the student such learning support facilities and other services it considers appropriate but may vary what it provides from time to time (provision of faculty availability and / or technology support).

TUITION PAYMENT SCHEDULE

WITHDRAWAL FROM THE PROGRAM & REFUND POLICY

You may withdraw from the school at any time after the cancellation period (described above) and receive a pro rata refund if you have completed 60 percent or less of the scheduled days in the current payment period in your program through the last day of attendance. The refund will be less a registration or administration fee not to exceed \$100.00. If the student has completed more than 60% of the period of attendance for which the student was charged, the tuition is considered earned and the student will receive no refund.

For the purpose of determining a refund under this section, a student shall be deemed to have withdrawn from a program of instruction when any of the following occurs:

- The student notifies the institution of the student's withdrawal or as of the date of the student's withdrawal, whichever is later.
- The institution terminates the student's enrollment for failure to maintain satisfactory progress; failure to abide by the rules and regulations of the institution; absences in excess of maximum set forth by the institution; and/or failure to meet financial obligations to the School.

For the purpose of determining the amount of the refund, the date of the student's withdrawal shall be deemed the last date of recorded attendance. The amount owed equals the weekly charge for the program (total institutional charge, minus non-refundable fees, divided by the number of weeks in the program), multiplied by the number of weeks scheduled to attend, prior to withdrawal. If the student has completed more than 60% of the period of attendance for which the student was charged, the tuition is considered earned and the student will receive no refund. Refunds are paid within 10 days of notification of withdrawal. Any balance due the Institute is due within ten days of withdrawal.

Sample Refund Calculation

In the first quarter, each course is 3 credits at \$225 per credit = \$675 per course. There are three courses per quarter. Each class is 10 weeks ($\$675 \times 10$) = \$67.50 per week per class. Three classes per week ($\$67.50 \times 3$) = \$202.50 tuition cost per week.

STUDENT TUITION RECOVERY FUND (California Students Only) (non-refundable)

The State of California established the Student Tuition Recovery Fund (STRF) to relieve or mitigate economic loss suffered by a student in an educational program at a qualifying institution, who is or was a California resident while enrolled, or was enrolled in a residency program, if the student enrolled in the institution, prepaid tuition, and suffered an economic loss. Unless relieved of the obligation to do so, you

must pay the state-imposed assessment for the STRF, or it must be paid on your behalf, if you are a student in an educational program, who is a California resident, or are enrolled in a residency program, and prepay all or part of your tuition. You are not eligible for protection from the STRF and you are not required to pay the STRF assessment, if you are not a California resident, or are not enrolled in a residency program. The STRF assessment is not required at this time.

VGI does not participate in Title IV funding. Per BPPE regulations: If a student obtains a loan to pay for an educational program, the student will have to repay the full amount of the loan plus interest, less the amount of any refund, and that, if the student receives federal student financial aid funds, the student is entitled to a refund of the moneys not paid from federal financial aid funds. If the student defaults on a federal or state loan, both the following may occur:(1) The federal or state government or a loan guarantee agency may take action against the student, including applying any income tax refund to which the person is entitled to reduce the balance owed on the loan.(2) The student may not be eligible for any other federal student financial aid at another institution or other government financial assistance until the loan is repaid.

The transferability of credits you earn at Viridis Graduate Institute is at the complete discretion of an institution to which you may seek to transfer. VGI will maintain a written record of the previous education and training of veterans and eligible persons, All records will clearly indicate that credit has been granted, if appropriate, the educational period shortened proportionately and the student notified accordingly.
