# South Carolina State Council Legacy South Carolina's Honor Role

Purpose: To recognize outstanding achievements and persons whose leadership made significant impact on the South Carolina Jurisdiction.

#### 1. Msgr. Joseph Bernardin

Rev P. N. Lynch Council 704, Charleston

- Born in Columbia, SC on April 2, 1928
- Baptized and confirmed at St. Peter Catholic Church in Columbia, SC
- Ordained to the priesthood April 26, 1952, by Most Rev. John J. Russell, Bishop of Charleston
- First State Chaplain of the South Carolina State Council for 1965-1967.
- Credited with initiating the State Charity Drive
- Vicar General of the Diocese of Charleston
- Appointed Auxiliary Bishop of the Archdiocese of Atlanta by Pope Paur VI in March 1966 – at 38 years of age, the youngest bishop in America.
- Served as the first General Secretary of National Conference of Catholic Bishops from 1968 to 1972.
- Appointed Archbishop of Cincinnati.in November 1972 by Pope Paul VI.
- Appointed Archbishop of Chicago by Pope John Paul II in July 1982. And elevated to Cardinal in February 1983.
- Died November 14, 1966.

#### 2. William Kenneth Johnson, FSW, PSD, FVSM Rev. P. N. Lynch Council 704, Charleston Rev P. N. Lynch Assembly 704 (1071), Charleston

- State Deputy of South Carolina Jurisdiction 1965 1967
- Supreme Warden 1967 1969. First and only Supreme Officer from South Carolina
- Vice Supreme Master of the DeSoto Province 1970 1978, First VSM from the South Carolina District
- Founded Soil Consultants, Inc. Foundation & Testing Engineers and served as its President from 1951 to 2001.
- Served as president of the SC Society of Engineers.







- He was a Fellow in the American Society of Civil Engineers (ASCE).
- Served as chairman of the Citadel CEF Foundation and served on the Advisory Board of the Citadel's Civil Engineering Department.
- Served in leadership positions in multiple civic organizations in the Charleston area.

#### 3. Fred M. Bultman, PSD

#### Bishop John England Council 724, Columbia

- Served as first State Deputy of South Carolina State Council, 1921 1923.
- (Served as the sixth and last State Deputy of the Carolina State Council, 1920 1921.)

# 4. John F. Rafferty

Rev P. N. Lynch Council 704, Charleston Rev. P. N. Lynch Assembly 704 (1071), Charleston

- Charter Faithful Navigator of the Rev. P. N. Lynch Assembly 704 (1071), the first Assembly established in South Carolina.
- (Served as the first State Deputy of the Carolinas, 1911-1912.)
- (Served for three terms as the fourth State Deputy of the Carolinas, 1915-1918.)

# 5. Arthur E. Anderson, FDM

Rev P. N. Lynch Council 704, Charleston Rev. P. N. Lynch Assembly 704 (1071), Charleston

- Through his personal effort and drive, he was instrumental in convincing the Supreme Council to form the Fourth Degree South Carolina District. 1950
- Served as the first Forth Degree District Master of the South Carolina District. 1950 - 1954

#### 6. First Charter Grand Knights in South Carolina

These leaders formed the first four Councils in the state of South Carolina. Within 7 months of the founding of Council 2207, the South Carlina State Council was established by the Knights of Columbus Board of Directors. – June 27, 1921. The first new council of the South Carolina Jurisdiction occurred 27 years later.


These leaders formed the first three Assemblies in the state of South Carolina. Eighteen months after the founding of Assembly 1668, the South Carlina Fourth Degree District was established by the Knights of Columbus Board of Directors - 1950. The first new assembly of the South Carolina District occurred 10 years later.

# 8. Judge William P. Donelan, PSD, FDM

Bishop John England Council 724, Columbia Bishop John England Assembly 724 (1072), Columbia

- Served as both the 10th & 12th State Deputy 3 terms 1939-1940 & 1941-1943.
- Served as the second District Master of the South Carolina Fourth Degree District 1954 – 1958.
- Quarterback for University of South Carolina.
- Elected to the South Carolina State Legislature and served in the General Assembly in 1935 and 1936.
- During World War II, he enlisted in the U. S. Marine Corp and served with distinction in the Pacific theatre and was honorable discharged at the end of the war as a Captain.



- Appointed to the South Carolina Supreme Court in 1977.
- Honored with Order of Palmetto on 2/3/1978 by Governor James B. Edwards. The Order of the Palmetto is awarded by a SC governor and is the highest civilian honor to South Carolinians who demonstrate extraordinary lifetime achievement, service, and contributions of national or statewide significance.

# 9. Francis B. Kerr, Sr., FDM

Rev P. N. Lynch Council 704, Charleston Rev. P. N. Lynch Assembly 704 (1071), Charleston

- Served as the 3rd District Master of the South Carolina Fourth Degree District. 1958 – 1962.
- Established the South Carolina District Exemplification Team in 1951 and served as the team director for over 50 years. The team, now known as the Charleston team, was the only exemplification team for the District until 2014.
- Served on the District Exemplification Team as the first Historian. Performed as the Historian for over 50 years. Known for his dynamic and impressive performance.
- Dynamic leader provided significant impact and mentoring to the SC District and District Masters for more than four decades.



#### 10. James N. Steadman, Jr. PSD

Rev P. N. Lynch Council 704, Charleston Rev. P. N. Lynch Assembly 704 (1071), Charleston

- Served as State Deputy 1961 1963.
- Youngest State Deputy 32 years, 1 month, 23 Days of age.
- Served on the District Exemplification Team as Registrar. Performed as the Registrar for over 30 years.



# 11. Joseph E. Moran, Jr. PSD

Rev P. N. Lynch Council 704, Charleston

- Served as State Deputy 1976 1978
- Responsible for the development of eight (8) new councils during his 2 years as State Deputy:

#### 12. Michael W. Telesco, PSD, FDM

Fr. Ronald P. Anderson Council 8900, North Charleston Rev. P. N. Lynch Assembly 704 (1071), Charleston

- Served three terms as State Deputy 1982 1985.
- Appointed the 8<sup>th</sup> District Master 1976 1980.
- Served as State Ceremonial Director for over 25 years.
- First 3<sup>rd</sup> Degree Conferring Officer in the state, [Note: 3<sup>rd</sup> Degree Conferring Officers were certified by a Supreme Council representative present at a live 3<sup>rd</sup> Degree ceremony.]
- Under his leadership, South Carolina State Council achieved 95 per cent certified First Degree Teams – the highest jurisdiction in the Order.



- After many years as the State Council HOPE Charity Chairman, he organized the establishment of the HOPE Foundation and served as director for over 20 years.
- Served as the State Council Historian, compiling a significant state history, especially the list of State Chaplains, District Friars, Charter Grand Knights, and Charter Council Chaplains.
- A dynamic leader who made a significant impact on the State Council acting as mentor for the State Deputies serving between 1980 and 2014. His impact and influence on the State Council cannot be overstated.

#### 13. F. Roosevelt Cummings, PSD, FDM

Msgr. Martin C. Murphy Council 6847, East Columbia Bishop John England Assembly 1071, Columbia

- Served two terms as State Deputy, 2002 2004. The first and only African American to serve as the South Carolina State Deputy.
- Appointed to serve two terms as the Fourth Degree District Master, 2006-2010. The first and only African American to serve as the South Carolina District Master.
- Established eight (8) new assemblies in the District. This is three times more new assemblies than any other SC District Master, [Note: Six other DM are tied for second with only two new assemblies.] This increased the number of assemblies in the District from 19 to 27, a 42% growth by one District Master.



# 14. Stephen T. Dunlap, PSD, FVSM, FDM

Msgr. Richard C. Madden Council 6629, Summerville Rev. P. N. Lynch Assembly1071, Charleston

- Elected to two terms as State Deputy 1990 1992.
- Appointed the 13<sup>th</sup> District Master 1994 1998.
- Appointed Vice Supreme Master of the De Soto Province, 1999-2003. The second SC Knight to be appointed VSM; 21 years after W. Ken Johnson.
- Published the "Palmetto Bulletin" monthly for the State Council from 1996 until 2024.
